1. INVOCATION

The invocation was given by Pastor Ted Soderholm, Catalina Church North.

2. **PLEDGE OF ALLEGIANCE**

All present joined in the Pledge of Allegiance.

3. PAUSE 4 PAWS

The Pima County Animal Care Center showcased an animal available for adoption.

4. CALL TO THE PUBLIC

Richard Hernandez spoke regarding appointments, elections and overspending.

The following speakers addressed the Board regarding homeless issues in the Pima Wash:

- Barbara Seelig
- Judi Bushe

They offered the following comments:

- The homeless were suspected in robberies, property damage and the abandonment of drug paraphernalia.
- Sheriff's deputies said there was nothing they could do about the homeless in the wash, but the plan provided by the County stated enforcement was the responsibility of the Sheriff's Department.

- Community members wondered why the homeless camps were being protected as residences.
- Drug kits were found in and around the homeless camps.
- Area residents were concerned about drugs, robbery and the lack of ordinances prohibiting the homeless from living on other people's property.

Christopher Cole, Libertarian Party, addressed the Board regarding the mortgage of County properties and in opposition to the agreement with World View Enterprises, Inc.

Raquel Baranow addressed the Board regarding the paper subdivision called Sycamore Vista, property liens on the empty lots for water and duplicity in the HOA.

Dennis Currie spoke on the release of the Star Valley plats, the problem with the Camino Verde inclusion and impact fees.

The following speakers addressed the Board regarding General Fund repayment from the Development Services Enterprise Fund:

- Steve Huffman, Tucson Association of Realtors
- Shawn Cote, Southern Arizona Home Builders Association
- Don Weaver, Green Valley Council

They offered the following comments:

- There was concern that the repayment could lead to an increase in the Development Services fees, beyond the established fee schedule.
- Any change that made building and construction more difficult ran the risk of hampering the housing industry.
- Fees from housing should not become a permanent source of funding for road repair.
- It was requested the repayment schedule be more reflective of market conditions and the fund's ability to repay be based on increased single family residence growth and not fee increases.
- The Board was encouraged to use the General Fund money for road preservation.

Brian Bickel addressed the Board in support of issuing the Certificates of Participation and communicated his understanding of the Resolution.

Kevin Kubitskey, Pima County Deputy Sheriff Association and Fraternal Order of Police, expressed concerns regarding proposed Sheriff's salary packages. He stated the package submitted by the Sheriff's Department received little to no support from the men and women it would be applied to and despite efforts to work cooperatively, felt they were being shut out of the process. He requested that adoption of the pay package submitted by the Sheriff be suspended due to the numerous unresolved issues.

5. CONVENE TO EXECUTIVE SESSION

It was moved by Supervisor Valadez, seconded by Supervisor Elías and carried by a 4-0 vote, to convene to Executive Session at 9:39 a.m.

6. **RECONVENE**

The meeting reconvened at 10:04 a.m. Supervisor Carroll was absent, all other members were present.

EXECUTIVE SESSION

7. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding filing an amicus brief supporting the position of the Arizona Sports and Tourism Authority in its anticipated appeal of trial court rulings in Saban Rent-A-Car v. Arizona Department of Revenue, TX 2010-001089, regarding the constitutionality of rental car surcharges.

Thomas Weaver, Chief Civil Deputy County Attorney, stated this case regarded the constitutionality of rental car surcharges and the Pima County Attorney's Office sought direction on whether to file an Amicus Brief supporting the Arizona Sports and Tourism Authority.

It was moved by Supervisor Elías, seconded by Supervisor Miller and carried by a 4-0 vote, to approve the County Attorney's recommendation as discussed in Executive Session.

8. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding an Offer of Judgment to defendants Nanos/Ruben in McConnell v. Nanos, et al., Superior Court Case No. C20135540.

Thomas Weaver, Chief Civil Deputy County Attorney, stated the County Attorney's Office sought direction on whether to proceed as recommend in Executive Session.

It was moved by Supervisor Elías, seconded by Supervisor Miller and carried by a 4-0 vote, to proceed as discussed in Executive Session.

COUNTY ADMINISTRATOR

9. Medical Insurance for County Employees - Fiscal Year 2016/17

Staff recommends approval of the following:

- A. The medical plans for Fiscal Year 2016/17;
- B. The premium amounts;
- C. The County HSA funding strategy; and
- D. Continuation of the Healthy Lifestyle Premium Discounts with the modifications proposed.

Jim Owen, Pima County Chapter Chair, Service Employees International Union (SEIU), stated the structuring of the premiums and discounts were deceptive and did not benefit the employees.

Art Mendoza, President, Service Employees International Union Arizona, said the Union has supported the County's transition to a self-insured model thinking it would provide controlled healthcare costs for everyone. SEIU has prepared a proposal that does not require additional County dollars but that fairly distributes the savings to be realized with the elimination of the PPO, reducing premium costs of the new HDHP2 Plan, increasing the tobacco free discount and funding of the HSA accounts consistently across all plans. He reported on the saving that would be realized if the SEIU proposal was adopted.

Supervisor Elías stated the elimination of the PPO would impact about 1200 of County employees and believed the cost shift discussed by SEIU was accurate.

It was moved by Supervisor Elías and seconded by Supervisor Valadez to approve the proposal of the Service Employees International Union for FY 2016/2017 medical insurance rates and to eliminate the second High Deductible Health Plan (HDHP2) option, as summarized below:

• The County Health Savings Account (HSA) funding strategy is \$1,000.00 per employee-only member and \$2,000.00 for employee, spouse and children, and family.

• Continuation of healthy lifestyle premium discount are continued with the exception that the nonsmoker or nontobacco user discount has increased from \$5.00 to \$ 20.00.

Chair Bronson questioned the financial impact to the County with the adoption of the SEIU proposal and elimination of the HDHP2 plan option.

Chuck Huckelberry, County Administrator, stated the proposal had been reviewed and the difference between the cost shift back to the County and the offset of the savings with the elimination of the funding for the HDHP2 was not of concern.

Upon roll call vote, the motion carried 4-0.

FINANCE AND RISK MANAGEMENT

10. Certificates of Participation

RESOLUTION NO. 2016 - <u>5</u>, of the Board of Supervisors, authorizing the lease and lease-purchase back of certain real property, including buildings and structures, in order to finance and refinance capital projects for the County; authorizing the execution and delivery of amendments and supplements to a Lease-Purchase Agreement and a Trust Agreement and other necessary agreements, instruments and documents; approving the execution and delivery of Certificates of Participation to provide the necessary financing and refinancing therefore; and authorizing other actions and matters in connection therewith.

It was moved by Supervisor Elías and seconded by Supervisor Valadez to adopt the Resolution. No vote was taken at this time.

Supervisor Miller added that of the \$25 million in refinanced Certificates of Participation from 2007, \$16.8 million was still owed.

Chuck Huckelberry, County Administrator, explained estimates, market influences, and the shortened repayment schedule.

Upon roll call vote, the motion carried 3-1, Supervisor Miller voted "Nay."

FLEET SERVICES

11. Annual Vehicle Exemptions

Pursuant to A.R.S. §38-538.03, staff requests the Board of Supervisors authorize the annual vehicle exemptions for 2016.

It was moved by Chair Bronson, seconded by Supervisor Valadez and carried by a 3-1 vote, Supervisor Miller voted "Nay," to authorize the annual vehicle exemptions for 2016.

FRANCHISE/LICENSE/PERMIT

12. Hearing - Fireworks Permit

The Chair inquired whether anyone wished to address the Board. No one appeared. It was moved by Supervisor Elías, seconded by Supervisor Valadez and carried by a 4-0 vote, to close the public hearing and approve the permit.

RECORDER

13. Hearing - Recorder's Office Fee Schedule Ordinance

ORDINANCE NO. 2016 - <u>10</u>, of the Board of Supervisors, establishing fees for election-related services, voter registration data and recorded document services provided by the Pima County Recorder.

The Chair inquired whether anyone wished to address the Board in objection to this item. No one appeared. It was moved by Supervisor Elías, seconded by Supervisor Miller and carried by a 4-0 vote, to close the public hearing and adopt the Ordinance.

TRANSPORTATION

14. Hearing - Traffic Resolution

RESOLUTION NO. 2016 - <u>6</u>, of the Board of Supervisors, permitting the temporary closure of portions of Pistol Hill Road from Colossal Cave Road to Old Spanish Trail in Pima County, Arizona, for the Colossal Cave Road Race on Sunday, February 28, 2016. Staff recommends APPROVAL. (District 4)

The Chair inquired whether anyone wished to address the Board. No one appeared. It was moved by Supervisor Elías, seconded by Supervisor Valadez and carried by a 4-0 vote, to close the public hearing and adopt the Resolution.

REGIONAL WASTEWATER RECLAMATION

15. Hearing - Pima County Code Text Amendment

ORDINANCE NO. 2016 - <u>11</u>, of the Board of Supervisors, relating to Wastewater Reclamation; amending the Pima County Code, Chapter 13.16, Design Standards for Public Sewerage Facilities.

The Chair inquired whether anyone wished to address the Board. No one appeared. It was moved by Supervisor Elías, seconded by Supervisor Valadez and carried by a 4-0 vote, to close the public hearing and adopt the Ordinance.

COUNTY ADMINISTRATOR

16. Use of General Fund Repayment from the Development Services Enterprise Fund

Staff requests direction regarding the use of Development Services Enterprise Fund repayments to the County's General Fund.

Chuck Huckelberry, County Administrator, provided a history of the Enterprise Fund, the downturn of the real estate industry and the subsidy of the General Fund to ensure solvency. He spoke of the repayment plan and explained he sought direction on the General Fund expenditure. He further explained that the repayment would go to the General Fund but had only been collected from the unincorporated areas of the County

Chair Bronson said several industry stakeholders expressed concern regarding the repayment plan and cautioned against increased Development Services fees to repay the debt.

Mr. Huckelberry stated Development Services Fees were automatically calendared for an increase at the beginning of the new fiscal year in July. He stated a fiscal forecast of the Enterprise Fund over the next few years would be prepared and that the repayment plan was approximately \$750,000.00 over the next several years.

Supervisor Elías stated District 5 would again be a donator district. He asked this item be continued to get more information regarding the stakeholders objections to the fee increase and the dollars District 5 would potentially be losing due to the use of the funds.

Supervisor Miller added she would like to add the discussion regarding the automatic increase of Development Services fees when this item returns to the Board.

Without objection, this item was continued to the Board of Supervisors' Meeting of March 15, 2016.

17. Fiscal Year 2016/17 Budget Adoption Schedule

Staff requests approval of the hearing schedule for the Fiscal Year 2016/17 budget adoption process.

It was moved by Supervisor Valadez, seconded by Supervisor Elías and carried by a 4-0 vote, to approve the following budget adoption schedule:

Budget Hearings to convene at 1:30 p.m.: April 19, April 26, May 3, May 10, and May 17, 2016 Tentative Budget Adoption: May 24, 2016 Final Budget Adoption: June 21, 2016

18. **Promotion Probation/Parental Leave**

Discussion/direction regarding promotion probation and parental leave.

Michele Garsha, Service Employees International Union, stated the adoption of a paid parental leave policy would improve employee retention, morale and productivity; disagreed with the County liability estimates; and supported removing parental leave from the CAT Bank.

Supervisor Elías spoke on the promotion probation matter and stated it would be an incentive for employee advancement. He supported moving the promotional probation back to 6 months. He also added that staff and SEIU had been directed last December to work together on the parental leave issue and that had not happened. He stated a delay was needed to get the information that had been requested.

Supervisor Valadez restated his direction from December that any action be as close to revenue neutral as possible.

It was moved by Supervisor Elías, seconded by Supervisor Valadez and carried by a 4-0 vote, to reduce the promotion probation period back to six months.

It was then moved by Supervisor Elías and seconded by Supervisor Valadez to continue the discussion on paid parental leave to the Board of Supervisors' Meeting of March 15, 2016, with direction to staff to work with SEIU, Pima County Deputy Sheriff Association and the Fraternal Order of Police, to develop a proposal for parental leave that was as close to revenue neutral as possible. Upon roll call vote, the motion carried 4-0.
