Hello,

I am writing to voice my opposition for a mandatory mask mandate of any kind in Pima County. I am especially against any mask mandate for schools. A mask mandate for schools within Pima County is in direct defiance of legislation that was passed by our Governor. Although it is not currently law, when it does take effect, it will be retroactive.

Masking was not recommended and deemed "useless" by both the CDC and Dr. Fauci during the early stages of the COVID 19 pandemic in 2020. In later months, they backtracked and advised masking as a way to signal to the population that "something" was being done, when in reality, there is very little we can do to limit the spread of this airborne virus. Masks did not suddenly become more effective due to better technology. The CDC and Dr. Fauci were well aware of mask limitations because of the numerous studies indicating as such. The availability of an effective vaccine, coupled with people who have natural immunity has created an extremely safe environment for our children. References for this claim will be included at the bottom of this email.

Aside from the scientific evidence cited below, I can recount anecdotal evidence. Last year, my child attended her 4th grade at a charter we have been with since kindergarten. We resumed in person education in early August, as a normal start to the school year, with modifications to pick up/drop offs, staggered lunch and recess, increased sanitation and required masking at all times. Classes or cohorts were quarantined to hybrid online education when a threshold number of COVID cases were reported. In most cases it was 1 person testing positive. The school self quarantined an additional 2 weeks around holidays as a precaution. Despite all the additional measures, typical childhood illnesses like Strep throat, pink eye, the common cold, influenza A and B and norovirus still managed to pass around the school at normal levels. We learned that COVID cases did occur, but in relatively low numbers based on the population. MASKING WAS NOT EFFECTIVE. Our children and teachers were burdened with the task of making sure that everyone was "safe". There is a real psychological effect of this scare tactic. The benefit does NOT outweigh the cost.

I am writing as a parent of an 8-year old whose school district offers no remote learning and does not require masks. **I urge you to vote in favor of Resolution 2021-56 so that our children can safely attend our public schools.**

Every morning for the last week, I have dropped my child off at school, knowing very well that he is walking into an environment where a dangerous virus is likely circulating. It is terrifying, and it is completely avoidable if people with power would just *do something and require masks to protect our children*. The situation is completely unacceptable.

For the last few weeks, we have painfully watched updates from schools around the state, quarantining entire grades, moving students online for remote learning, and reporting numerous (even hundreds) of students and teachers out sick. And we have watched the numbers of Arizona children contracting and hospitalized with COVID-19 continue to increase. We know more and more Pima County schools and children will be affected if nothing is done to mitigate against the virus. And we know our youngest children--who are ineligible to be vaccinated--are currently protected only by universal masking. Parents are just waiting in pain, hoping against hope that it is not *our* children who are the unlucky ones, that it is not our families who will have to face the consequences.

I hope the Board of Supervisors will not continue to wait for the legal uncertainty to change. Our children need your help now. **Please implement mask requirements in our schools immediately.** Every day you wait is another day for the virus to spread--and we can be sure that it already is.

Please make the right decision today.

Good Afternoon Pima County Board of Supervisors:

I wanted to reach out to all of you regarding the upcoming agenda for the Board of Supervisors meeting on August 16<sup>th</sup>.

If mask mandates are again brought up for a vote, I implore each of you to oppose any action to create any emergency declaration requiring mask mandates, especially for our school children.

As I'm sure you know, Governor Ducey recently signed an executive order rescinding paragraph 5 of executive order 2020-51 which canceled the mask requirement in all school districts.

As I'm sure you are aware, A.R.S § 26.307(A) states: *State agencies when designated by the governor, and counties, cities and towns may make, amend and rescind orders, rules and regulations necessary for emergency functions but such shall not be inconsistent with orders, rules and regulations promulgated by the governor*, which makes any rule requiring face coverings in schools illegal.

The effectiveness of mask use in children is not well documented and poses health and developmental risks.

Children (and adults) are not able to recognize and interpret facial queues and interactions with other students and teachers when wearing face coverings.

Additionally, face coverings in children can change their breathing patterns and make them more prone to becoming "mouth breathers" which can cause a variety of health problems.

The requirement of children to wear a mask or face covering for extended periods can cause masks to become wet which can expose them to increased bacterial conditions as well as labored breathing and increased carbon dioxide levels. Personally my child has difficulty wearing masks and exhibits respiratory difficulties when wearing them as well as dermatological issues.

The hierarchy of controls, for the purpose of this discussion, for protecting persons from exposure to airborne contaminants, ( from most effective to least effective) should be:

- Proper ventilation which is an engineering control.
- Social distancing which is an administrative control.
- Podding which is an administrative control.
- Lastly, and least effective, are face coverings / mask use which are personal protective equipment controls.

When we research and explore the hierarchy of controls for the exposure to hazards and the effectiveness of the controls, we find that engineering controls are much more successful in mitigating hazards than PPE.


Additionally a large amount of over the counter masks that are being used are relatively ineffective because COVID particles are too small to be blocked by the mask media.

I strongly encourage you to consider my position with your fellow board members when making your policy decisions. It should be the decision of parents as to the masking status of our children.

As a matter of course, I have copied the office of Mark Brnovich, Arizona Attorney General on this correspondence.
