## **Dear County Supervisors:**

I am writing to you as a concerned Arizona resident, former high school biology teacher, and mom of 3 kids, asking that you re-consider adopting a County Resolution requiring universal masking in K-12 schools within county boundaries.

Children in Arizona have a right to safe schools. However, safety is NOT what is happening in the majority of schools in this county and state. Within just the first days back to school, countless parents have received "exposure notices" and multiple schools have had to move entire classrooms or even multiple grade levels back to remote learning due to widespread cases. Not only is this a harm to the physical health & well-being of our students and their families, it is a public health concern for the entire community. Widespread school outbreaks will lead to undo stress on our already burdened hospital systems and put economic strain on businesses as thousands of caregivers have to miss work due to sick and quarantined kids.

The clause snuck into the budget bill by the legislature that removes local control and bans schools from implementing such policies is likely unconstitutional. Furthermore, this "law" doesn't take effect until Sept. 29 and poses a serious risk to public health. It's already having disastrous effects on our school campuses. This short-sighted attempt to ban masks and mitigation in our schools goes against the recommendations of the consensus of public health experts including that of the CDC, the American Academy of Pediatrics (AAP), Arizona Department of Health Services, and the Pima County Public Health Department. All of these agencies are calling for layered mitigation strategies including universal masks for all K-12 students and staff in schools.

Unfortunately, the virus has mutated to a much more transmissible form and it is imperative that we change course as a result. According to Banner Health Chief Clinical Officer, Dr. Marjorie Bessel, hospitals have seen a 95% increase in Covid-19 patients since July 1 and the AAP has just reported a recent 84% increase in pediatric cases. Some children's hospitals in other states are reporting completely full PICUs. Pediatric specialists and intensive care teams are an incredibly finite resource. Please do everything in your power to see that our children in your communities will still have access to quality care and take appropriate measures to limit their need for hospital care in the first place.

Please choose to stand with our children in supporting a safe return to the classroom by adopting a County Resolution requiring masks in K-12 schools as soon as possible.

Thank you to the Pima County Supervisors who voted in favor of this critical Resolution.

I urge Pima County Supervisors to bring the issue back to the Board of Supervisors on Monday, August 16 and to vote in favor of the County Resolution requiring a universal mask requirement in K-12 schools. A county mandate will help keep our children and community safe.

According to Banner Health Chief Clinical Officer, Dr. Mariorie Bessel hospitals have seen a 95% increase in Covid-19 patients since July 1 and 300% increase in ventilators and there is substantial spread in the vast majority of Arizona counties. Arizona is also second in the nation for pediatric deaths related to COVID-19, according to data published recently by the American Academy of Pediatrics. The science around masking is settled. Masks work to prevent disease transmission. All recent public health agencies, both national and local, have issued statements recommending universal masks for K-12 students in schools.[1]

Arizonans have a right to safe schools for Arizona kids. Governor Ducey is attempting to prevent school officials from implementing any public health mitigation strategies in line with leading public health agencies, including the CDC and Arizona Department of Health Services (ADHS) to help protect students, all while COVID19 cases are again rising in our communities and more contagious variants are becoming more widespread.

The law passed by the state. banning schools from implementing such policies is likely unconstitutional, doesn't take effect until Sept. 29 and poses a serious risk to life and health.

Pima County has a duty to protect the health of the community under Arizona law. Arizona Revised Statute Title 36 authorizes counties and local health jurisdictions to protect the health of the community during contagious diseases outbreaks. It is your duty to take action.
