Appointment of Democratic Party Member to Election Integrity Commission

***Introduction/Background:**

On July 1, 2008, the Board of Supervisors established the Election Integrity Commission for the purpose of providing independent oversight of the county election process. Nine members are appointed; one by each of five Supervisors, one by the County Administrator, and one by each of the three political parties currently recognized in Pima County. Each Commission member's two-year appointment must be ratified by the Pima County Board of Supervisors.

***Discussion:**
