Dear Member of the Board of Supervisors,

I would like to express my concerns regarding Voting Centers and Electronic Poll Books. I strongly urge you to vote **NO** on both issues. The following are my reasons for why you need to vote **NO** on voting centers and **NO** on electronic poll books:

This proposal creates chaos by having too many changes of a process or a system at the same time. You are looking to change locations, electronic systems (two of them), and shifting of people who will need additional training.

This proposal is an absolute assault on election integrity. Common Sense would inform a person of average intelligence that depending on electronic equipment particularly that which is connected to the internet can be hacked and manipulated with very little ability to detect what has occurred on the other side of the computer screen.

Reduction of the voting polls to establish voting centers is a suppressive act of the vote. People go to the polls that is close to their own homes and where they have confidence in their neighbors that know them to count the votes as they cast them. Changing the location will lead to discourage some citizens from voting due to the extremely long lines that this act will cause.

Voting Centers will increase the opportunity for fraud as many people can choose to attempt to vote in multiple centers which would go against one person one vote and everyone having equal voice.

Implementation of printing out ballots on the day of also contributes to the chaos of more votes being cast without verification or integrity in relationship to the voting rolls.

I seriously question the motives of those whose money is behind driving these proposals and I do not want to hand over a responsibility of public officials to private vendors that would have their own agendas in manipulating the outcome of elections.

I also disagree with electronic poll books and, for that matter, electronic voting machines. Electronic devices can be tampered with or hacked. I'm requesting my comments below be read into the record at the next Pima County Board of Supervisors Meeting:

Supervisors' Scott, Heinz, Bronson, Christy and Grijalva

First, I want to thank the Board of Supervisors for reconsidering the implementation of Voting Centers and E-Pollbooks. With the 2022 primary election season literally being just a few months away it's prudent of the Board to step back and determine if Pima County is ready for such dramatic changes in our elections.

For the Boards reconsideration:

The proposal of Voting Centers is a 57% reduction in previous voting locations, and with redistricting it's now over 60% reduction. This is not an insignificant percentage.

Federally uncertified E-Pollbooks from Apple, utilizing 3rd party vendors and web services are connected to the internet. This is not an arbitrary point, voter information should not be handled by private vendors.

Counties with Voting Centers and E-Pollbooks (in Arizona and other states) often have long wait lines. Some as long as 8 hours. What if long lines happen in Pima County?

The first roll out day of this experiment will be in August with 100+ degree heat.

Does the Board of Supervisors really want to be responsible for risking the health of our in-person voters? Some who are elderly and disabled.

From a January 2022 meeting with the Recorder and Election Director, each stated what their major concern was for the upcoming election.

Election Director: *"The public's view of their office"*

Recorder: *"The biggest concern is voter confidence"*

Why would they make such statements, then weeks later push through major changes that disenfranchises our in-person voters? Are they really concerned or not? Or more likely they want a better public perception, but they will do what they want. Let's face it from a business perspective more automated and centralized makes it much more convenient to run an election. The public's voice and trust has been placed with the

According to your March 1st Addendum to the Agenda, you will vote to reconsider two votes from your February 15th meeting. I urge you to vote to reconsider & vote against establishing voting centers & awarding a contract to Tenex.

1) using **vote centers in place of polling places for the 2022 Primary and General Elections** - This will be confusing to voters who have consistently voted at the same location for years. It would also inconvenience voters that would need to travel greater distances to get to a voting center. And further, voters would likely experience longer waiting lines. Voting is our sacred right & currently, the majority of AZ voters have concerns with election integrity. I ask that you recognize this public distrust & change your vote so voting centers are NOT established.

2) **awarding of the contract to Tenex Software Solutions, LLC** - Don't waste Pima County taxpayer dollars on a system that could be vulnerable to hackers. Reported in 2020:

"Dallas County bought the new equipment in order to have new voting centers so voters can vote anywhere in the county on Election Day. But it turns out \$6 million were wasted on poll books made by one company that can't securely function with voting machines made by a different company.

It turns out Dallas County Commissioner J.J. Koch says new equipment unveiled in the November 2019 election could have been vulnerable to hackers.

"We purchased something entirely too quickly, and it ended up costing taxpayers now additional millions of dollars," he said. "Largely because of security features. In fact, we had an unsecure election."

The county spent \$6 million with a company called Tenex to purchase electronic poll books."

I am requesting that my comments below be read into the record of the next Pima County Board of Supervisors meeting.

Dear Supervisor Bronson, Scott, Christy, Grijalva, Heinz:

I have 20 years experience working in the polls during various kinds of Elections. In 2020 I was an Inspector for the Primary and General Elections in Pima County. **The most serious problem we had in my voting area was at least 10 voters who ALWAYS vote in person discovered they had been mailed an Early Ballot when they did NOT request one and NEVER have. You know these voters. Proud parents with their kids, Veterans, etc. They had to vote provisionally. THIS WOULD NOT HAVE BEEN ADDRESSED BY** the Pima County Elections Department's and Recorder's Office's proposal to implement Voting Centers, Electronic Pollbooks and Ballot Printers.

I urge you to vote **NO** on this proposal because roughly four months before the 2022 voting season begins, the Elections Department and the Recorder's Office want to change THREE SEPARATE THINGS ABOUT HOW WE VOTE IN PIMA COUNTY:

1. **NUMBER OF LOCATIONS** - an almost 60% reduction in voting locations TO 100.

- **THIS REVERSES THE DECISION YOU TOOK LAST SEPTEMBER TO KEEP THE NUMBER OF PRECINCTS AROUND 249.**

2. **TECHNOLOGY** - automated Voter Rolls and Ballot Printers in every Voting Center

3. **PROCESSES** - for Voters, Poll Workers, Partisan Observers and Candidates

I am writing to urge the Board of Supervisors to continue to support the implementation of vote centers in Pima County in your upcoming March meeting. There are so many reasons to support vote centers; they are faster, more efficient, more accurate, and require fewer workers. However, to me, the most important reason to support vote centers is that fewer votes will be cast as provisional ballots, or not cast at all, which means more voters will have their voice heard through their votes.

A few years ago, before I signed up to vote by mail, I went to the wrong polling place. I stood in a long line, but when I reached the poll worker, she said I was not on the voter list. They called another poll worker who also looked at the list, but could not locate my name. They did not know why I was not on the list, and they did not refer me to my correct poll location or offer me any other assistance. Although I was able to find the correct polling location later that day, if I did not have independent transportation or the time to figure out where to go, I may not have been able to vote. I do not want any voter to be disenfranchised because of a mix-up or limited resources.
