ORDINANCE NO. 2013 - \_\_\_\_, An ordinance of the Pima County Board of Supervisors, establishing Bullfinch Drive as a through street in Pima County, Arizona. Staff recommends **APPROVAL**. (District <u>3</u>)

The reason for this ordinance is to establish Bullfinch Drive as a through street and provide regulatory authorization of the existing stop and yield signs at the intermediate cross streets installed due to sight distance restrictions.

A routine traffic study determined that Bullfinch Drive from the north line of Valencia Road to the south line of Razorbill Drive is functioning as a through street, with the minor roads regulated through stop or yield control. No ordinance was found to authorize the existing traffic controls for the intersections as installed by the developer. Due to sight distance restrictions at several of the intersections, the existing traffic control devices are needed and this ordinance will provide for enforcement through designation of Bullfinch Drive as a through street.

# AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS ESTABLISHING BULLFINCH DRIVE AS A THROUGH STREET IN PIMA COUNTY, ARIZONA

**WHEREAS,** the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate through streets and erect stop or yield signs, and

**WHEREAS,** the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to designate Bullfinch Drive as a through street,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

- **SECTION 1.** Bullfinch Drive be designated a through street from the north line of Valencia Road to the south line of Razorbill Drive.
- **SECTION 2.** All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.
- **SECTION 3.** This ordinance shall take effect when and to the extent that stop or yield signs are posted on the intersecting streets.
- **SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.
- **SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
