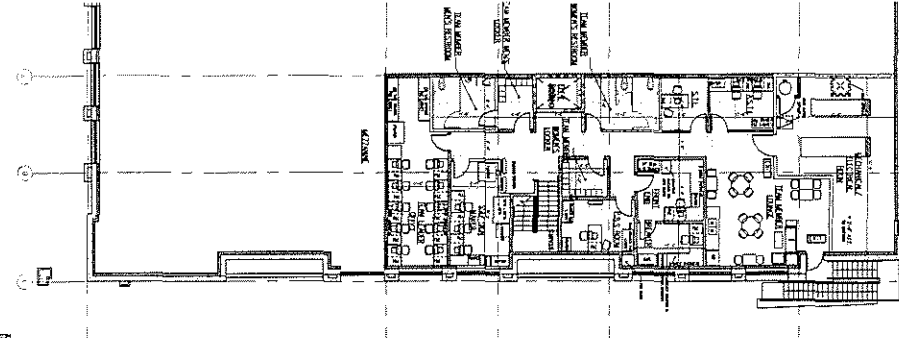
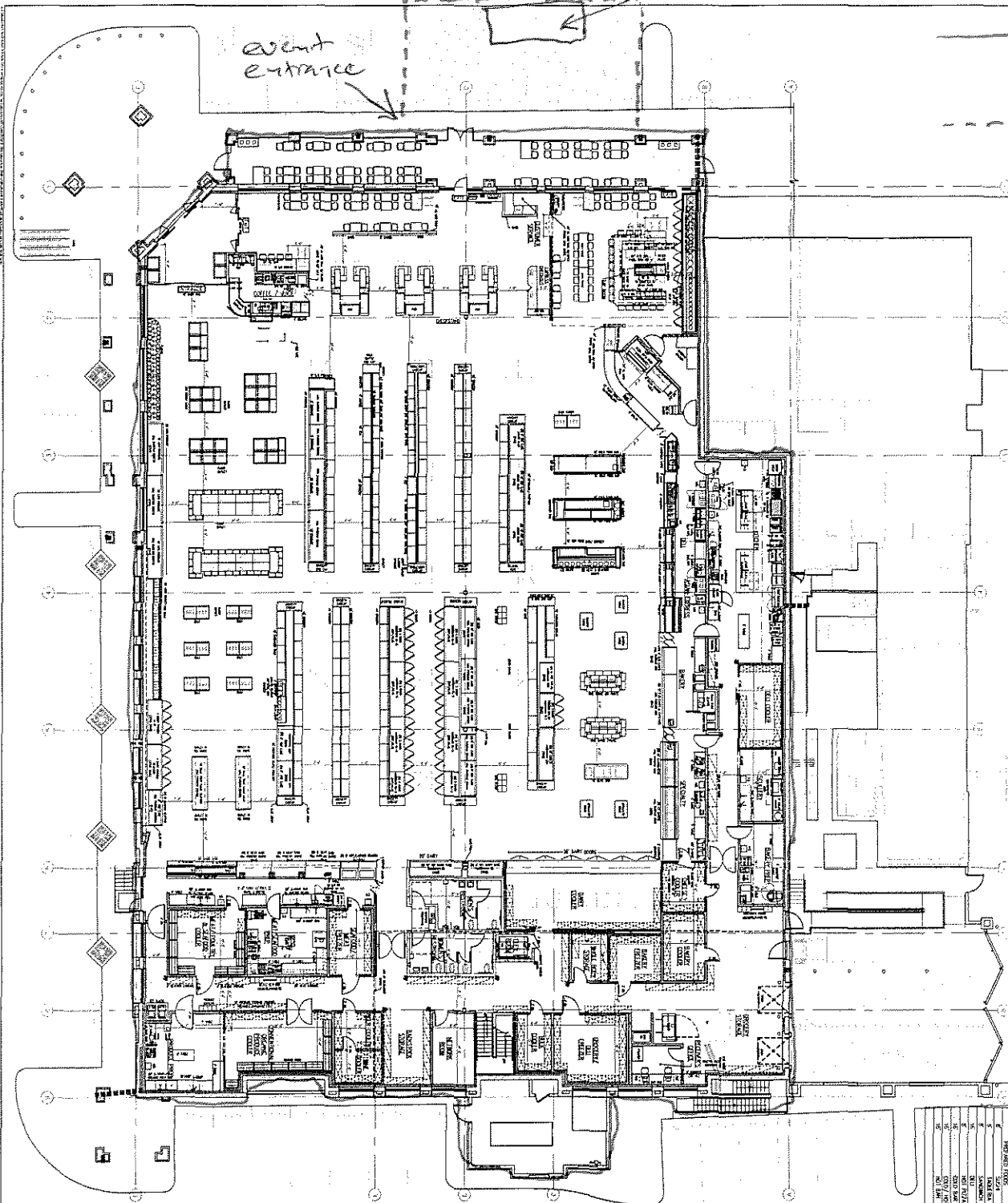

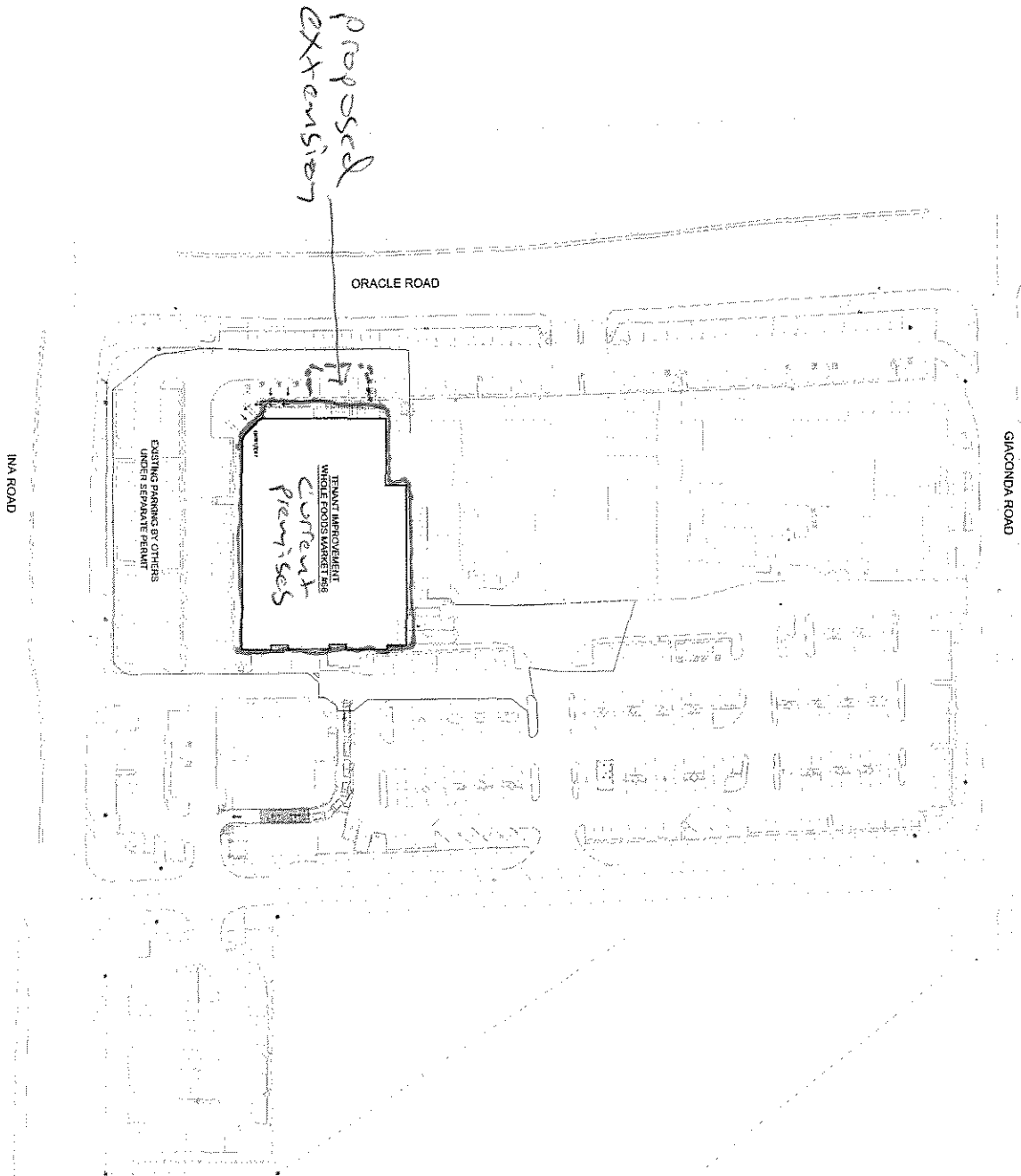

"Base Camp" Event

October 22, 2014

The Base Camp event will take place on October 22, 2014 from 5:00PM to 9:00PM. We would like to extend our Series 7 Beer/Wine bar license to a small area outside the store for this event.

The event will be located in a designated outdoor area on the East side of our building, immediately adjacent to our enclosed patio seating area. We will use ropes to create a barrier around the portion of the event area that is not currently enclosed by our patio fence. Beer will be served from a portable bar, located in the roped-off area. Please see the attached floor plan and site plan for more details on the proposed event location.

Guests will enter the event area through one designated entrance, where ID's will be checked, they'll be given a wristband if they are of legal age to consume alcohol, although it not prof at time of service, those who do not receive a wrist band will not be served any alcohol. We expect the event to draw about 75 attendees.

The event will be supervised by our trained staff, and no one under 21 will be served, nor will any guests who are visibly intoxicated be served. We will follow all the normal alcohol service guidelines that are currently in place at our store.
