Message Subject Monsanto Meeting in Ward 3

Comment Hello there, I am one of Sharon Bronson's constituents. I am unable to attend the ward 3 meeting on Jan 17th due to a court conflict. I want you to know my concern regarding Monsanto building greenhouses in Avra Valley. I have a PhD in nutritional sciences from the University of Arizona. I also have several autoimmune diseases that have forced me onto disability. One of the medical issues is severe gut dysfunction. I have found food sprayed with pesticides and even more so food that has the Bt DNA inserted into it (Roundup Ready) causes my gut to temporarily shut down requiring several days of medications and careful attention to the food I eat to get it back to it functioning. When Monsanto first introduced glyphosate as a pesticide, it was unknown that the human gut had the same bacteria that the pesticide uses to kill off various plant insects. We now know that we have this bacteria and it is necessary for good gut health. Consuming food that has been sprayed with glyphosate or food that has the Bt gene insertion (Roundup Ready) causes die off of the beneficial bacteria that the human and animal guts need to thrive. Many people can consume these products with little harm but those of us with already compromised gut function suffer greatly. However, growing GMO foods is very risky due to pollen drift. It has been well documented that pollen from Bt corn can spread quickly via the wind and end up contaminating other fields. Allowing Monsanto to grow test plots of experimental seeds and GMO crops is very likely to introduce more GMO crops in the area by cross pollination especially with corn. Dear County Supervisors:

In all honesty, every time I sit down to eat I get angry at the Congressional Representatives who voted to oppose mandatory labeling of GMO/GE/Laboratory Altered foods. I am writing to express my concern and in fact strong opposition to the presence of Monsanto in our community. Monsanto uses a chemical called Glyphosate (Roundup) on its genetically modified crops. Glyphosate has been shown to be hazardous to human health in study after study (note - studies that are NOT funded or skewed by Monsanto). 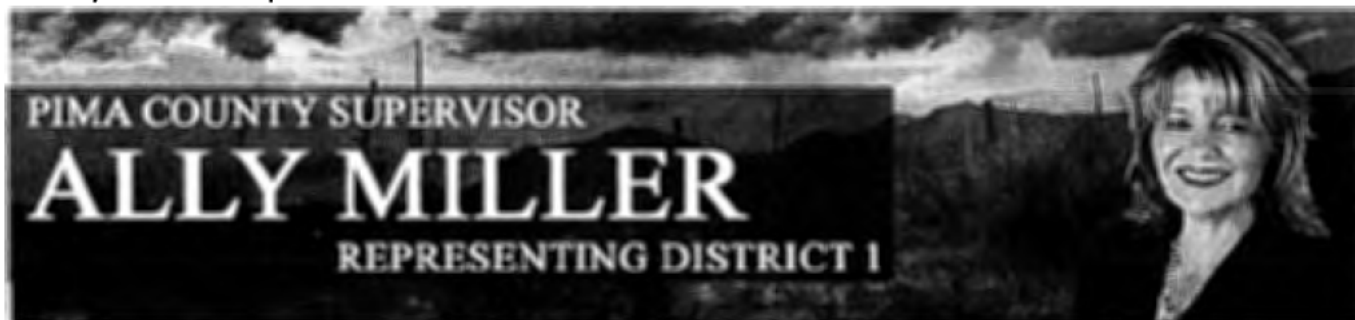



Dear Ms. Castaneda, Supervisor Ally Miller, Supervisor Sharon Bronson, Supervisor Ramon Valadez, Supervisor Steve Christy, and Supervisor Richard Elias,

I respectfully request that you not allow Monsanto to obtain the FTZ or PILOT designation, allowing them to significantly reduce their taxes to Pima County. As you know, Monsanto has been the purveyor of some of the most toxic substances known to man (including DDT, PCB's, dioxin and Agent Orange), the latter which to this day Monsanto denies causes any health concerns despite the consensus of health experts and multiple research studies, including the CDC, Institute of Medicine (now the Health and Medicine Division at the National Academy of Science, Engineering and Medicine), and the VA. Thus, their credibility is at best questionable. While initially they will be keeping crops limited inside a greenhouse, there is nothing to stop them from eventually planting GM crops out in the open with their many associated problems (below), no matter what they promise now.

Monsanto's environmental record has been reprehensible, with contamination of the area surrounding many of their projects (ex. Hawaii and South America)(<http://www.i-sis.org.uk/argentinasRoundupHumanTragedy.php>) and associated, significant increases in severe, long-term health problems in those communities. While they claim that the greenhouse project will be very safe, limiting the possible escape of their genetically modified product, accidents can and will happen, which will end up tainting our environment and put our native crops at risk. Besides problems with cross-pollination, GM crops have been found to grow where they were never cultivated (<http://www.nature.com/news/2010/100806/full/news.2010.393.html>), so it is not inconceivable that any escaping product can contaminate the environment, even at distances not proximate to the greenhouse or its original target area, as reported in the *Nature* article.

Monsanto claims that the GM products have been created to help feed the world by decreasing use of chemicals, decreasing the need for water, increasing yield, and thus improving sustainability. While GM crops do initially decrease the use of herbicides and pesticides, resistance to both has been developing rapidly, producing superweeds, requiring increased use of herbicides (glyphosate) and the need to add another herbicide-resistance gene to newly-developed GM crops, as well as the need to spray pesticides on crops formulated to be resistant to insects (<https://www.scientificamerican.com/article/farmers-say-gmo-corn-no-longer-resistant-to-pests/>). To date, GM crops also have not required less water and therefore are not more sustainable than conventional and definitely not more than organic agriculture. While GM crops initially had better yields than conventionally- or organically-grown crops, this is no longer true, as a recent comparison of canola crop yield between Canada (where GM canola is cultivated) and Western Europe (where GM canola is not used) shows (https://www.nytimes.com/2016/10/30/business/gmo-promise-falls-short.html?smid=fb-share&_r=0). Therefore, all the advantages that Monsanto and GMO proponents tout are nonexistent.

I know the amount of taxes that Monsanto would be paying over what is being received from that property at present and the promise of 25-50 jobs with benefits make it very tempting to accept their offer and the FTZ designation. However, Monsanto made over \$7B in 2016, so they do not need tax breaks -- we are going to need the money they should be paying in taxes to remedy the impact on the environment and the health of Pima County residents, especially those in the Marana School District close to the property.

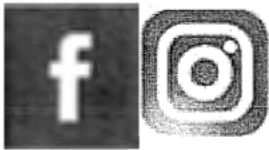

Pima County Board of Supervisors,

Please vote **no** on **Monsanto's request for Federal Trade Zone Designation**. The following questions and concerns are prompting county wide opposition.

1. Since 1901 Monsanto has specialized in the production of highly toxic chemicals. The sale of Roundup, a highly toxic weed killer brought Monsanto \$4.8 billion in revenue in fiscal 2016.

They also produce GMO seed. Within a few years, the weeds develop stronger strains, and the herbicides loose effectiveness, and so Monsanto is continuously developing new more toxic weed killer, and stronger strains of GMO seeds that are not harmed by Roundup.

2. Roundup kills weeds and other plants that are not the GMO produced seeds of Monsanto. This poses a threat to our local natural and organic farms, and our desert landscapes.

3. Do we have any guarantees that Monsanto will not use the 155 acres as an open field farm to develop and test new unapproved chemicals and GMO seeds?

4. The 'Agreement' with Monsanto is actually a 'non binding understanding.' So Monsanto can legally change their plans on how to use the 155 acres they have bought in Avra valley at any time.

5. After receiving FTZ designation, Monsanto could decide to alter or abandon the greenhouse project for economic reasons: i.e., too expensive to build, too high construction costs, too many employees required. This would leave the county with no economic benefits from giving Monsanto tax breaks.

There's no current market for greenhouse cultivated seeds. To determine the effectiveness of the new toxins on open GMO farms, they will need to conduct open field research of the new GMO seeds and the new untested, and unapproved toxic chemicals to be used in the latest versions of Roundup.

6. Glyphosate in Roundup is a non-selective herbicide, meaning it will kill most plants. Oregon State Univ.

7. Local windstorms, and monsoons on experimental crops in open fields, would contaminate the air, the drinking water, and the soil, posing a potential threat to organic and traditional crops on neighboring farms, and the traditional tribal crops of the neighboring Tohono O'Odham Indian Reservation.

8. Roundup and GMOs: a potential threat to our Saguaro Cactus, and the environment in ur National and State and local Parks. An Avra Valley test site for new Roundup and GMOs poses a long term threat to the Saguaro cactus and other indigenous desert plants in the Saguaro National Park, the Sonoran Desert Museum, and other neighboring parks. What will our desert landscape look like after 10 years of exposure to Monsanto's 155-acre test lab?

9. In the next 10 years, we could see the collapse of our \$2.2 billion tourist trade. The neighboring 95-acre Sonoran Desert Museum draws 750,000 visitors annually to see their 1,200 plant species, and 230 animal species. The Saguaro Nation Park has 400,000 visitors every year.

10. **The following local businesses depend on the tourist trade:** resorts, hotels, rental condos and apartments, B&Bs, golf courses, hundreds of restaurants, entertainment, stores, boutiques, galleries, grocery stores, gas stations, site seeing, parks, museums, transportation, and malls. The 40 jobs Monsanto is promising won't compensate for the loss of jobs, businesses, sales tax revenues, and loss of quality of life in Pima County.

11. **California has just made the determination that Roundup's chemical Glyphosate is carcinogenic.** U.S. Law says that researchers cannot buy seeds from Monsanto for research purposes without Monsanto's approval. All research in the US is with companies that Monsanto approves of. All the new conclusive evidence of the harmful effects of Roundup and GMOs is being conducted by companies and individuals in other countries.

12. **Recent Scientific Research definitively confirms that serious liver disease has resulted from chronic ultra-low dose of Roundup exposure.** 2016. Prof. Gilles-Eric Seralini of the Univ. of Caen, France, and follow up studies at King's College, London, Dept. of Medical and Molecular Genetics, by Mesnage R, Renney G, Seralini GE, Ward M, Antiniou, MN. Rats given an extremely low, environmentally relevant dose of a commercial Roundup, thousands of times below what is permitted by regulators, resulted in non-alcohol fatty liver disease.

13. **Roundup exposure from GMO foods 'can have serious health consequences, especially for children'.** Leonard Trasande, Prof of Pediatrics, Environmental Medicine and Population Health, NYU School of Medicine.

A test lab and the probability of testing in open GMO fields to be conducted 1.5 miles from Marana High School is not taking care of the health of our children.

14. **EPA currently investigating whether Glyphosate-based herbicides are safe for human exposure.** Cathy Milbourne, press officer for the US.EPA said they are currently reviewing the Kings College Study, and Glyphosates

15. **Communities around the world have been involved in hundreds of law suits** against Monsanto for the harm these chemicals have done to the health of their crops, and their communities. Monsanto does not have a good track record when it comes to international trade. "Seed, The Untold Story". Documentary film.

16. **Current Lawsuits Against Monsanto.** Delaware, last Wed, and last month in New York, and California: lawsuits accusing Monsanto of long knowing that the glyphosate in Roundup was hazardous to human health. Reuter.com, Tucson.com.

17. **May 26, 2016. Monsanto ordered to pay \$46.5 million .in PCB lawsuit.** At least 700 lawsuits against Monsanto are pending, claiming that their non-Hodgkin lymphoma was caused by exposure to PCBs manufactured until the late 1970s. These PCB lawsuits give evidence of long term effects of Monsanto's untested toxic chemicals on human health.

The County should be allocating the tax revenues from Monsanto to build new roads, support the schools, and to reduce taxes for small local farms, and businesses. And we may need those tax dollars to cover the costs of future law suits against Monsanto if we were to discover unreported spills, contamination of our drinking water, our schools, and farms.

It is clear that Monsanto does not have a history of developing a good, strong working relationship with the communities they enter. They are in the business of showing profits for their shareholders. They have not proven that they are reliable partners in the business of growing a strong economic future for the communities they move to.

To ensure that we are creating a vibrant future for our community, we ask that The Board of Supervisors hold Public Hearings giving their constituents a chance to speak directly with their elected officials.

Please vote No on FTZ Designation, and No on a tax break for Monsanto.

First a detail: I'm putting this in text form in this email, but realize that the links are not likely to stay "live," so I'll add the letter as an attached document in case you want to refer to them. You can also cut-and-past the URLs into a browser.

February 7, 2017

Greetings Pima Supervisors,

Having lived in Tucson 20 years till moving to Patagonia this fall, I'm writing as a citizen who's adopted Southern Arizona with a passion, and as an architect who continues to serve clients in Pima County as well as other nearby counties, working toward environmentally responsible house design. My two sons are U of A students also very fond of the Tucson area, and their mom is business owner in the Foothills. Please hear me as a citizen of our bioregion, if not technically of the county at the moment.

I'm offering my thoughts from the awareness that the Sonoran desert is a single, living ecological region, independent of city, county, state, or national borders. For instance, in helping resist ecologically destructive Big Mining proposals in Pima and Santa Cruz counties, I'm working at the moment to protect the Santa Cruz River watershed, and the headwaters of the Pantano Wash, and thus to protect the water supplies of Tucson and adjacent towns.

However, I'm writing you now concerning the Monsanto proposal for a research facility in Marana, where a major tax break has been proposed in order to lure this project as a contributor to the County's coffers, it seems. But why offer them a break, at taxpayer expense? They are such a huge and profitable corporation (197th in Fortune's top 500), that they don't need a break. Monsanto's net sales in 2016 were \$14.86 billion, which is about 14 times the Pima County's total revenues of \$1.07 billion (from the Adopted Budget FY 2016/17. The profit motive is further mirrored by the total compensation of CEO Hugh Grant, as reported by Forbes: \$12.84 million in a recent year, and \$143.18 million over 5 years.

Beyond its greed, Monsanto has a long track record, since its founding in 1901, of operating viciously and illegally, and has been called "the world's most dangerous corporation," and you can learn why at this link:

The major pernicious practices of Monsanto are:

carcinogenic chemicals, starting with its 20th-century introductions (and later defenses) of DDT and Agent Orange.

2. The genetic engineering of organisms which threaten the natural biodiversity essential for survival, and which are marketed as “Roundup-ready” seeds. GMO corn, for instance, in scientific studies with mice thus far, is being shown to cause tumors, cancer, organ failure, and premature death.

3. The attempt to control – and even patent – seed production, now controlling over 80% of the markets for soy, corn, cotton and canola seed. This has included manufacturing and selling “suicide seeds,” which don’t reproduce and force farmers to keep on buying new Monsanto seeds.

4. Further history of Monsanto is at <https://en.wikipedia.org/wiki/Monsanto>, including its involvement with PCBs and the early development of nuclear weapons.

In short, it’s clear that Monsanto’s business operations are based on a heartless exploitation ethic. The consequences are part of the ecological destruction which Mother Nature will resist with the beginnings of what’s been called “the Sixth Mass Extinction,” so this is a very serious matter indeed.

This situation has evolved from a century of distancing ourselves from nature and blind repetition of the mantra of “jobs and growth,” but that limited way of thinking has proved ecologically disastrous and needs to change. Some jobs are OK; some are not. Some growth is OK, some is not. (As Edward Abbey abruptly reminded us, “Growth for the sake of growth is the ideology of the cancer cell.”) Without a shift of all of our consciousnesses and economies toward ecological wisdom, we are, quite factually, doomed.

But what’s the alternative? For Pima County, can David beat Goliath? Can we learn to think and eat differently?

1) Please learn about and support the diverse and healthy local food movement, from “farm to table,” including articles in the magazine EDIBLE BAJA, local seed libraries and seed banks, community gardens, permaculture projects and teachings, and gardens that teach in local schools such as TUSD’s Tucson High and Manzo Elementary School (recognized as a Best Green School for 2012 by the U.S. Green Building Council’s Center for Green Schools.) Please give these efforts your full and enthusiastic support in order to help Pima County move toward local self-sufficiency and “food wisdom”, working toward people-based Sonoran resilience in the face of the possibly staggering changes yet to come as human-induced climate change increases from a trickle to a torrent. (Hopefully there are no “deniers” among you?)

2) Pima County could join the majority of nations who have banned genetically engineered foods, and the chemical industries which create them. It’s an international movement, as you can learn about at https://www.organicconsumers.org/old_articles/gefood/countrieswithbans.php. It’d be great to have the U of A agree, and the whole State of Arizona, as well as the nation, but right now the County can do such a ban unilaterally. Pima would thus join other US counties in leadership, such as Mendocino County in CA, and Kauai and Hawaii Counties in Hawaii. (An introduction to this worldwide movement can be found at https://en.wikipedia.org/wiki/Genetic_engineering_in_the_United_States.)

3) Pima County could also ban the use of Monsanto’s popular herbicide Roundup, as many communities and nations have. (SCIENTIFIC AMERICAN presents the carcinogenic potential of glyphosate in this 2015 article: <https://www.scientificamerican.com/article/widely-used-herbicide-linked-to-cancer/>.) Technical help will be needed for farmers and landscapers making this transition.

...and there are lots of other efforts worth supporting in the shift from corporatocracy to a life- and people-based world view in what's becoming the quest for survival in this century. The shift also must be away from fossil-fuel related emissions, toward renewable energy, and eventually, population limitation....but those are for future conversations.

Initially, the transformation to a world view based on a profound respect for the living systems which sustain us, might not produce as many short-term dollars and tax breaks for the already rich, but it will lead to healthier and longer lives for a far greater number of Sonoran residents of all species. It's tough work to change our heads around in this way, but what's more worthwhile?

With Valentine's Day coming next week, I urge you to muster up the clear conviction to care for the future generations -- hopefully seven of them, as our indigenous elders have urged -- and not to prostitute the county to a flashy newcomer.

Thanks for your consideration, and please know that many of us "out here" support you in JUST SAYING NO to Monsanto, as we seek a livable, less toxic future. As I see it, we elected you to serve the people, not just a few corporations, and now's the time to remember that. This debate asks all of us to examine -- as deeply as we dare -- what we REALLY love.

2.7.17 STATEMENT TO THE PIMA COUNTY BOARD OF SUPERVISORS

You may have thought otherwise, but you now know you have veto power over Monsanto's federal trade zone application. That means the responsibility to make the right decision for the future of Pima County lies in your hands.

If you didn't know much about Monsanto before, that's common. Monsanto has done everything it can do to keep Americans in the dark for 20 years. But the growing number of people who have learned about the business practices of Monsanto know that it has fixed the system by infiltrating colleges and schools, government regulatory agencies, and the judicial system so that it can get its claws into a community. And, then once the people and even elected representatives see how Monsanto ruins an area with the toxic business it does, it's too late. When the people fight back and pass initiatives, say, to prohibit biotech corporations from operating in that area or simply to let the public know what chemical pesticides Monsanto is spraying and when, Monsanto files lawsuits and keeps the issue tied up in the courts. We saw that in a movie that was sold out at The Loft on Sunday.

In your deliberations at the Nov. 22nd meeting, one of the main arguments for giving Monsanto its foreign trade zone status was so that it would give you a memorandum of understanding so we would know what Monsanto is doing on its property. That's like thinking it will work out well if you enter into an agreement with a sociopath. That MOU is not binding. Do not have the hubris to think you can successfully make a deal with Monsanto and not have our community suffer the same plights as other communities, like those in Hawaii, have suffered.

This is so much more than a decision about increasing the tax base. This is no time to be shortsighted. Monsanto is trying to use its greenhouse as a cover to get its foreign trade zone status and then use the rest of its more than 140 acres as a testing ground for experimental crops sprayed with experimental chemicals that will get into our air, water, and food. Uphold your duty to protect Pima County and the health of its residents and use your power to kill its foreign trade zone application!

As the Executive Director of the Rocky Mountain Seed Alliance and former Director of Native Seeds/SEARCH, I urge the Pima County Board of Supervisors not to support Monsanto's application for Foreign Trade Zone status for its 155-acre property near Twin Peaks and Sanders Road in Avra Valley.

I understand the difficulty in making a decision to jeopardize the move into Pima County of a large, job-creating and tax-generating corporation. In the end, those of you who actually vote on this issue probably will not be held personally responsible, either for lost tax revenue for Pima County, potential genetic contamination to local agriculture, dangerous chemical residues or resulting bad publicity. You do live in the county, however. This is your home. Your children may live here for a long time. What kind of a world do you want them to live in?

Facing an uncertain future, people all over the world are looking for authenticity and safety. People everywhere are shortening supply lines. A paradigm shift is upon us. Smaller farms growing fresher foods from locally adapted seeds are proving to be more ecological, more resilient, more sustainable and in the end more stimulating to local economies. The best and brightest and healthiest people want to move to places like this. Surely you understand the value of the World City of Gastronomy designation from UNESCO, an agency of the United Nations, bestowed upon Tucson last year. Tucson has become a recognized food cuisine destination fostering much needed tourism revenue for our state.

We know now the promise that Big Ag will feed the world and enrich local communities is a myth. The model it represents externalizes costs and leaves local economies poorer. Ken Meter, economist at The Crossroads Institute, estimated a \$5 per week shift alone toward the purchase of locally grown food in Southern Arizona by Southern Arizona families would bring an additional \$280 million a year to our economies. Has Pima County explored what this would mean for local tax revenues? Pima County should be known as the leader in this effort. Tax breaks for the world's most hated corporation would represent the opposite. Please think about the long-term consequences of your decision.

Re: "No" on Monsanto FTZ designation

I implore you to vote "no" on the upcoming vote regarding Monsanto. You have heard hours of public testimony about the threats, risks, and potential environmental liabilities Monsanto could represent for Pima County.

You have before you an unprecedented opportunity to hit a home run. From the November 22 Board meeting, through every board meeting since then and all five district meetings on this subject, the public has voiced landslide opposition to Monsanto's plans in Pima County, with the proportion of speakers in opposition to Monsanto running at 95% or greater at each meeting.

It may be a long time before you come across another issue where you have conservatives, liberals, and independents all coming together in 95% agreement on anything. You have the chance to endear yourselves to the hearts and minds of the voters you represent by taking a stand on this issue to side with your constituents in Pima County.

I am reminded of an anecdote from the district meeting in Green Valley on this subject, where one member of the public stood up and spoke so fondly of what retired Supervisor Ray Carroll had done for the community in opposing the Rosemont mine. I thought to myself, what a wonderful thing, for any of us, to be remembered fondly for our good work after our retirement. I think all of us would want that for ourselves, would we not? I certainly would love to be remembered fondly like that after my own retirement one day.

You have that same opportunity here. Day after day, week after week, month after month, meeting after meeting, you have heard from members of the public who are Republicans, Democrats, and Independent voters coming together to say "no" on Monsanto. I can't think of a better way for you to enhance your status with the 95% voters of all stripes with one vote, can you? (Conversely, I think that when 95% of the public has spoken in unity on an issue, a vote against the will of the public makes it difficult, to say the least, to ever convince your constituents again that you truly represent their needs come re-election.)

According to an article in the Arizona Daily Star 1/28/17 (attached, *Pima County Board Has Veto Power over Monsanto's Tax Breaks*), the board *does* in fact have veto power over the proposed Monsanto tax break. According to Sun Corridor Inc.'s own website (and we all know Supervisor Bronson is listed as in the Chairman's Circle of Sun Corridor Inc.), on the FTZ page, a power point presentation describes Pima County as the "*gatekeeper*" on obtaining the FTZ designation. You have the power to say "no" to supporting the FTZ designation. According to Monsanto's own Amanda McLleran, who spoke at the district meetings, Monsanto has not decided whether the project will move forward in the absence of the FTZ designation. (She said they are waiting to see this process play out.) This means

your vote on this issue is critical to whether the project would potentially go forward.

On a final note, I can't help but mention an article in the Arizona Daily Independent 2/1/17 (attached, *Monsanto's Roundup Barred From Supervisor's Meeting but Okay for High Schoolers*) that notes that if I wanted to bring in a bottle of Roundup, Monsanto's flagship pesticide that is sprayed on fields of its crops that people eat, to show you at the meeting, I would not be allowed to do so because the product presents a "security risk." Pocket knives and pepper spray may be allowed, but the Monsanto Roundup product is considered too dangerous. The implication is clear: Roundup®, with its active ingredient glyphosate, is too dangerous to be near the Board of Supervisors, but it's okay to use a mile from a high school, and even closer to other residents of the Avra Valley. (I also note that according to the same article there are ongoing disputes with Saguaro National Park and Tucson Water over aerial spraying of glyphosate which has sickened Avra Valley residents and their pets, and killed a rancher's cattle forage.)

As a business owner myself, I'm not opposed to business. But I am opposed to businesses with a bad track record of unethical practices. So as far as Pima County is concerned, I would go as far to say, let's bring in *anyone* but Monsanto. What I think would be even better would be to look at other ways to support Pima County. For instance, if everyone in Pima County shifted \$5 of their weekly food budget to locally grown food, that would bring in \$260 Million annually into Pima County. Instead of giving away tax dollars to Monsanto, I'd rather my tax dollars go to a public service campaign in support of locally grown foods, as one idea for food for thought, pardon the pun. All that to say, there are other ways to accomplish your goals for Pima County without risks to the health, safety, and welfare of the public in the way that Monsanto's practices have brought to numerous other municipalities that are now embroiled in litigation in 2017 for the clean up of the environmental damage from Monsanto's presence.

Do the right thing, let's sidestep the Monsanto risks from the get-go. Step up to the plate, swing for the fences, and go home a hero. Vote "no" on Monsanto. Let's recognize this danger for what it is and say no to this Faustian bargain.
