Re: **Appointment of Megan Page as Pima County Public Defender**

Following receipt of the pending resignation of Pima County Public Defender Joel Feineman, a process was developed to evaluate potential candidates and recommend the most qualified which has been outlined in the April 13, 2022 memorandum from the Public Defense Services Director, Dean Brault. The Evaluation Committee interviewed six highly qualified applicants in which I interviewed two candidates on April 12, 2022 and it is my recommendation to the Board of Supervisors to appoint Ms. Megan Page as the Pima County Public Defender.

Subject: Recommendation for Pima County Public Defender appointment

---

Following the announced resignation of Pima County Public Defender, Joel Feinman, a committee was formed to select a recommended replacement. The committee was composed of Rosemarie Pena-Lynch, Director of the Maricopa County Office of Public Defense Services, Kate Vesely, Director of Justice Services, James Fullin, Pima County Legal Defender, Mary Trejo, City of Tucson Public Defender, and myself. The position was posted on the Pima County website and was open to all County employees. We received six applicants, all of whom were qualified for the position. All six applicants were interviewed by the committee. Following those interviews, the committee unanimously recommended Megan Page to be presented to the Pima County Board of Supervisors for appointment as the Pima County Public Defender.

Ms. Page received her Bachelors of Arts in history from the University of Arizona in 2007, graduating Summa Cum Laude. She received her Juris Doctor from the University of Arizona James E. Rogers College of Law in 2010, again graduating Summa Cum Laude. In August of 2010, she started as a Judicial Law Clerk for the Honorable Deborah Bernini at the Pima County Superior Court.

Ms. Page was hired by the Pima County Public Defender as an Assistant Public Defender in 2011 as a felony trial attorney, handling a full caseload that included all types of cases including homicides and sexual assaults. She was promoted to be a Team Leader of one of the Adult Felony Trial Teams in 2017. In 2018, she was selected to be the Chief Assistant Public Defender. In that position, working with the Public Defender, she has effectively managed the attorneys and staff of the Public Defender's Office and been a strong leader that has garnered respect from all aspects of the criminal justice system in Pima County.
