Requested Board Meeting Date: October 3, 2017

Title: Aerospace Parkway No Parking

Introduction/Background:

Flights will be arriving and departing from World View Enterprises, Inc. in the near future. The flights are expected to draw attention from the community, and it is anticipated that citizens may stop within the Aerospace Parkway right of way to observe these flights.

Discussion:

Aerospace Parkway is recommended to be regulated as No Stopping, Standing or Parking due to possible spectators utilizing the roadway right of way to view the flights from World View Enterprises, Inc.

Conclusion:

Pima County Traffic Engineering recommends Aerospace Parkway from Nogales Highway to Alvernon Way be regulated as No Stopping, Standing or Parking. This regulation will improve the potential for safety by removing the availability of the Aerospace Parkway right of way for vehicles to stop to observe the flights.

Recommendation:

Pima County Traffic Engineering recommends Aerospace Parkway from Nogales Highway to Alvernon Way be regulated as No Stopping, Standing or Parking.

ORDINANCE NO. 2017-___

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING PARKING ON AEROSPACE PARKWAY IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not stop, stand or park on Aerospace Parkway from Nogales Highway to Alvernon Way,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Parking on Aerospace Parkway from Nogales Highway to Alvernon Way shall be regulated No Stopping, Standing or Parking.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.




