Please be sure to add my comments below into your After-Actions Report and into official records. These are comments that I wrote to the Board of Supervisors 9/6/2022 and the Pima County Election Integrity Commission 9/23/2022.

I was an observer in the primary 8/2/22, at Sahuaro Church on Houghton Road and Old Vail Road. I was dismayed about the chaos these vote centers and electronic equipment failures have caused.

- 1. People drove around their neighborhood, intending to vote and could not locate a familiar voting location.
- 2. E-poll books (ties to Russia, Web Certificate) and Lexmark printers (Chinese owned) did not work from 6am to 12:30, for 6 ½ hours!
- 3. Voters were sent away to another location; they were disenfranchised. Violation of the 14th Amendment.
- 4. Voters that were sent away, may not have been voting at all. Again, violation of the 14th Amendment.
- 5. Ballot count did not add up. Did someone walk away with a ballot during chaos when e-poll books & printers didn't work?
- 6. Election staff was courteous and professional despite major chaos. They may not come back to work for another Election disaster.
- 7. Constance Hargrove demonstrated to us during a Pima Co Board meeting when Adelita Grijalva had no ID on her, that anyone can circumvent the system. Tab, tab and voila, Ms. Grijalva could vote. That is not a secure nor a reliable system.
- 8. Please consider getting rid of these unreliable machines! None are legally certified per HAVA Act of 2002 by a Federally certified testing lab.
- 9. Please go back to secure paper ballots, hand count, one-day voting, voter ID and signature verification.

Please address these concerns.

Neither the logistics of the election process nor the ability to review the process after the election have been satisfactorily vetted. Remove the total new system - return to one legal vote, one paper ballot at our Precincts. Replace the ineffective (and possibly incompetent) Constance Hargrove from her position. .

Agenda 10-04-22 County Administrator Item #16 2022 Election After Action Report dated 9-13-22 The information provided is 16 pages of various summaries and action with numerous attachments for 2022 and 2020. Since you indicated you could not compare activity and results between a General Election with a Primary Election why bother with all the paperwork? I thought your goal with two mock-election trials was to assure that the Primary Election would be conducted without concerns. The Election Department failed promises. Your outcomes and goals in the After Election Report continuously indicate that issues and problems will be corrected. You said that before, why should the Elections Department performance be expected to be any different.

Additionally, Constance Hargrove, Elections Director sent a 31 page "After Action Report Updates and Response to Election Integrity (EIC) Recommendations on September 29 to Jan Lesher. Lots of suggestions, recommendations, more money, more employees, more expense. What happened to the cost savings generated by the new system and confirmed by earlier comments by Constance Hargrove? This memorandum addressing the EIC recommendations as of today 10-2-2022 is not yet even posted on the Elections Commission website nor on the 10-04-22 Agenda for Item #16 as prepared by the office of Jan Lesher. One good solution is to remove Constance Hargrove from her employment. Obvious grounds are lack of performance in a critical position. Abandon the new system in its entirety. Return to one legal vote, one ballot, at our established Precincts. We need BOLD steps for BOLD action, time is running out to take two steps back and again wait for solutions.
