RESOLUTION NO. 2013 - ____, A resolution of the Pima County Board of Supervisors permitting the intermittent, temporary closure of Swan Road in Pima County, Arizona, for the annual El Tour De Tucson on Saturday, November 23, 2013. Staff recommends **APPROVAL**. (District 1)

The reason for this resolution is that the Perimeter Bicycling Association of America, Inc., requests permission to intermittently, temporarily close Swan Road northbound travel from 3,065 feet south of River Road to Sunrise Drive for an annual bicycle race. The street closure shall occur Saturday, November 23, 2013, from 10:00 A.M. to 11:30 A.M.

The Pima County Sheriff's Department, the Pima County Department of Transportation, the City of Tucson Police Department, and the City of Tucson Department of Transportation agree that Swan Road should be intermittently, temporarily closed during the El Tour De Tucson 2013 event.


