## **Project Title/Description:**

Communication Tower Site Lease Agreement between Pima County and Southern Arizona TV Stations, Inc.

## Purpose:

This contract amendment between Pima County and Southern Arizona TV Stations, Inc. is made pursuant to §§ A.R.S 41-2631 through 41-2634 and is effective upon execution by the Board of Supervisors.

Pima County Wireless Integrated Network (PCWIN) has a contract with SAT to lease space on Mt. Bigelow for the location of radio communications equipment. The contract includes terms for payment of annual rent and monthly electricity service.

This amendment extends the lease term for four (4) years and includes an annual rent increase as stated in the original contract.

WHEREAS, CONTRACTOR and COUNTY, pursuant to Article 2 - Term, have agreed to extend the Lease term for a period of years (4) years; and

WHEREAS, CONTRACTOR and COUNTY have agreed to increase the rental amount to allow payment for the continued provision of communications site use during the extended term of the Lease; and

WHEREAS, CONTRACTOR, and COUNTY, pursuant to Article 21 – Notice, have agreed to change the contact information for Pima County.

NOW, THEREFORE, it is agreed as follows:

CHANGE: ARTICLE 2 - TERM:

To: "County shall pay to SAT Sixteen Thousand Two Hundred Seven and 33/100 Dollars

(\$16,207.33) ("Base Rent") for the first year of the Term. Base Rent shall increase by 3%

for each subsequent year during the Term."
