Introduction

Tucson's Man and Woman of the Year awards were first given in 1952. The Metro Tucson Chamber began sponsoring the awards event in 1983, and the Founders Award was added to the program in 1985. The Greater Tucson Leadership (GTL) has maintained the tradition of these awards beginning in 2012.

On February 7, 2014, GTL will honor Pima County Attorney Barbara LaWall with the Founders Award. The Founders Award honors individuals who have demonstrated significant long-term community involvement and service and who have helped build a better community. Previous Founders Award recipients include Mr. Roy Drachman, Ms. Cele Peterson, Former Tucson Mayor Lew Murphy, and Ms. Marian Lupu.
