I am submitting this letter on behalf of Save the Scenic Santa Ritas Association, concerning the proposed "*Ordinance to Regulate Certain Unpaved Roads to Maintain Healthy Air Quality*" to be considered by the Pima County Board of Supervisors during the Dec. 2, 2025 public meeting.

Save the Scenic Santa Ritas Association strongly supports passage of this ordinance and requests the Board of Supervisors adopt the following two amendments:

Amendment I

Replace "75 ADT" with "50 ADT" in the following Sections:

- a. Section 10.37.10, paragraph 1
- b. Section 10.37.20, paragraph 2
- c. Section 10.37.30, paragraph 2
- d. Section 10.37.40, paragraph 2

Amendment II

Penalties

Section 10.37.40

Paragraph 3:

Second ~~or later~~ offense or failure to comply with a NOC. Any person, firm, or entity who fails to comply with NOC is subject to a civil sanction for which the court shall impose a sanction in the amount of ~~\$500~~ \$1,000 per truck, per day requiring compliance within 14 days.

Add Paragraph 4:

Third offense or failure to comply with a NOC. Any person, firm or entity who fails to comply with NOC is subject to a civil sanction for which the court shall impose a sanction in the amount of \$10,000 per truck, per day requiring compliance within 14 days.
