Pima Animal Care Center (PACC) was awarded a \$3,000 grant after participating in a Challenge (May 1-31, 2022) to create/expand a community-based pet foster-care program. PACC will use the grant to help implement the program it piloted during the Challenge.

**\*Procurement Method:**

**\*Program Goals/Predicted Outcomes:**

Expand PACC's Safety Net short-term foster care program for pets whose families are in temporary crisis due to hospitalization, eviction or other concerns, and help ensure these pets/families are eventually reunited. Also, create community awareness of PACC's pet foster care program and increase number of foster caregivers.

**\*Public Benefit:**

Reduce shelter overpopulation through foster placements and related adoptions; open more kennel space for incoming animals.

**\*Metrics Available to Measure Performance:**

Track number of pets placed in either Safety Net or other foster care program, and count number of people who volunteer as foster caregivers.

Programs were expanded to include all types of animals from neonatal kittens to large dogs and fospice pets. Many of these included foster-to-adopt and Adoption Ambassador programs, with 6,738 animals adopted directly from foster homes.

Adoptimize, Greater Good Charities, National Animal Care and Control Association and The Association for Animal Welfare Advancement are providing additional prizes for this challenge and will be notifying their winners directly in the coming weeks.

## Payment

For prizes \$5,000 or less, this grant will be paid via check from Maddie's Fund, and we'll begin processing your payment within the next two weeks. The check will be mailed to the address of the Payment Contact you indicated on your grant application.

For prizes \$5,001 or more, this grant will be paid via ACH payment through Bill.com. The Payment Contact you indicated on your grant application will receive an email from Bill.com asking them to connect with Maddie's Fund. Once the invitation is accepted and the account created, you will receive the payment as an ACH transfer.
