The Board will discuss the continued employment of Teresa Cullen in Pima County later today. I want to voice my strong condemnation of her. She should be removed. During her testimony for the position of Arizona Department of Health Services Director she articulated the core of the problem with government in Pima County. On multiple occasions she showed that she was 'not responsible' for the directives regarding Covid during her tenure. In this she was correct.
