CONTRACT AMENDMENT

WHEREAS, COUNTY and CONTRACTOR entered into a Contract for services as referenced above; and

WHEREAS, CONTRACTOR and COUNTY have agreed to increase the contract amount to allow payment for the continued provision of services during the extended term of the contract.

CHANGE: ARTICLE I - TERM:

CHANGE: ARTICLE III - PAYMENT:

From: "Total payment for this Contract shall not exceed \$100,000.00."

To: "Total payment for this Contract shall not exceed \$150,000.00."

The effective date of this Amendment shall be September 1, 2013.
