Requested Board Meeting Date: February 20, 2018

**Title:** Broadway Boulevard and Freeman Road All-Way Stop

**Introduction/Background:**

The Pima County Department of Transportation received requests from citizens, and Saguaro National Park representatives for the installation of an all-way stop at Broadway Boulevard and Freeman Road. The intersection is currently a two-way stop, with vehicles on Freeman Road stopping for those on Broadway Boulevard.

**Discussion:**

Broadway Boulevard and Freeman Road are both classified as urban collector roadways. The northbound and southbound approaches on Freeman Road consist of the majority of the average daily traffic, sixty-two percent, yet these approach directions are currently stop controlled. A fatal crash occurred at this intersection on September 27, 2017 when a westbound vehicle hit a northbound vehicle that ran the stop sign. Since 2008, nine of the twelve crashes that were reported at the intersection are types of crashes for which an all-way stop can be a countermeasure.

**Conclusion:**

Based on the requests received, the average daily traffic at the intersection, and the crash history, Broadway Boulevard and Freeman Road is recommended to be an all-way stop.

**Recommendation:**

The Pima County Department of Transportation recommends the intersection of Broadway Boulevard and Freeman Road be designated as an all-way stop intersection.

ORDINANCE 2018 - \_\_\_\_\_

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING TRAFFIC AT THE INTERSECTION OF BROADWAY BOULEVARD AND FREEMAN ROAD IN PIMA COUNTY, ARIZONA**

**THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:**

1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. §§ 28-627 and 28-855 to designate stop intersections and to erect stop signs.
2. The Board of Supervisors has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to designate the intersection of Broadway Boulevard and Freeman Road as an all-way stop intersection.

**BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:**

SECTION 1. The intersection of Broadway Boulevard and Freeman Road be designated an all-way stop intersection.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take into effect when and to the extent that stop signs are posted on the intersecting roadways.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
