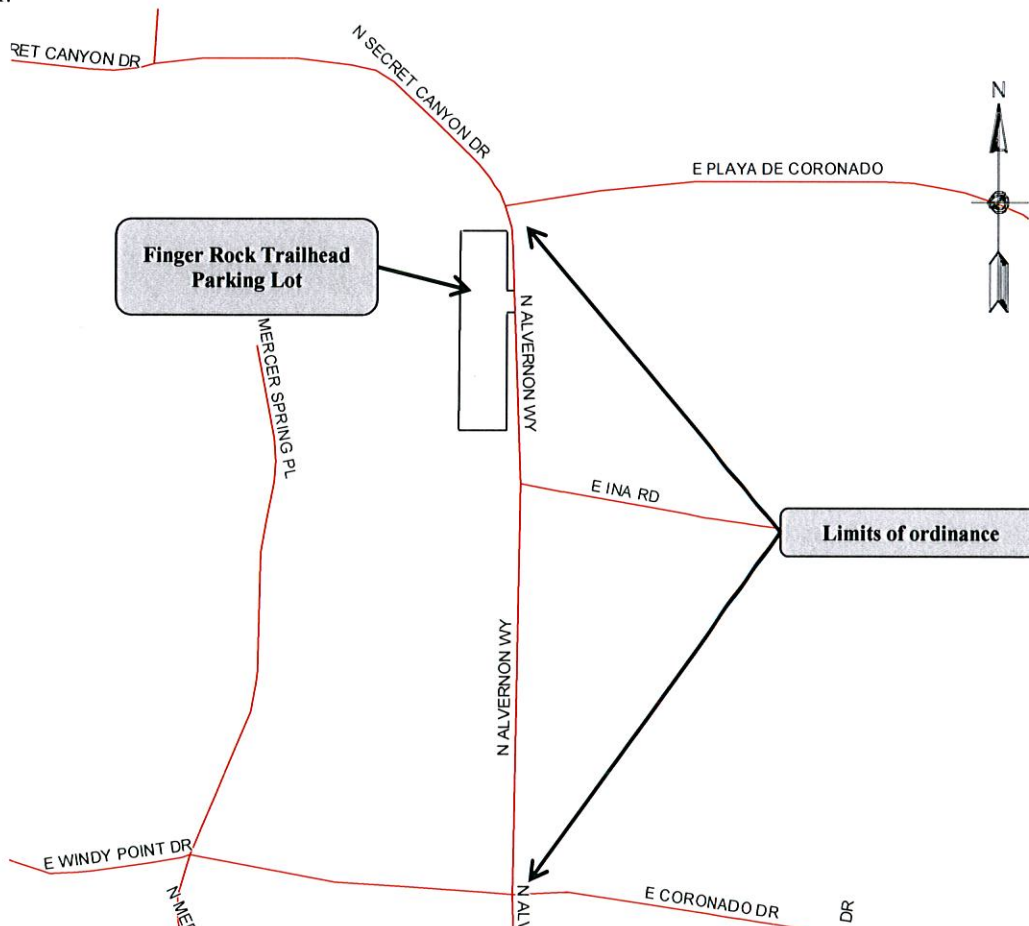

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS REGULATING PARKING ON
ALVERNON WAY IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not park anytime on Alvernon Way from Coronado Drive/Windy Point Drive to Playa De Coronado/Secret Canyon Drive,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Parking on both the east and west side of Alvernon Way from Coronado Drive/Windy Point Drive to Playa De Coronado/Secret Canyon Drive be regulated No Parking Anytime.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted to on the highway herein listed giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.




