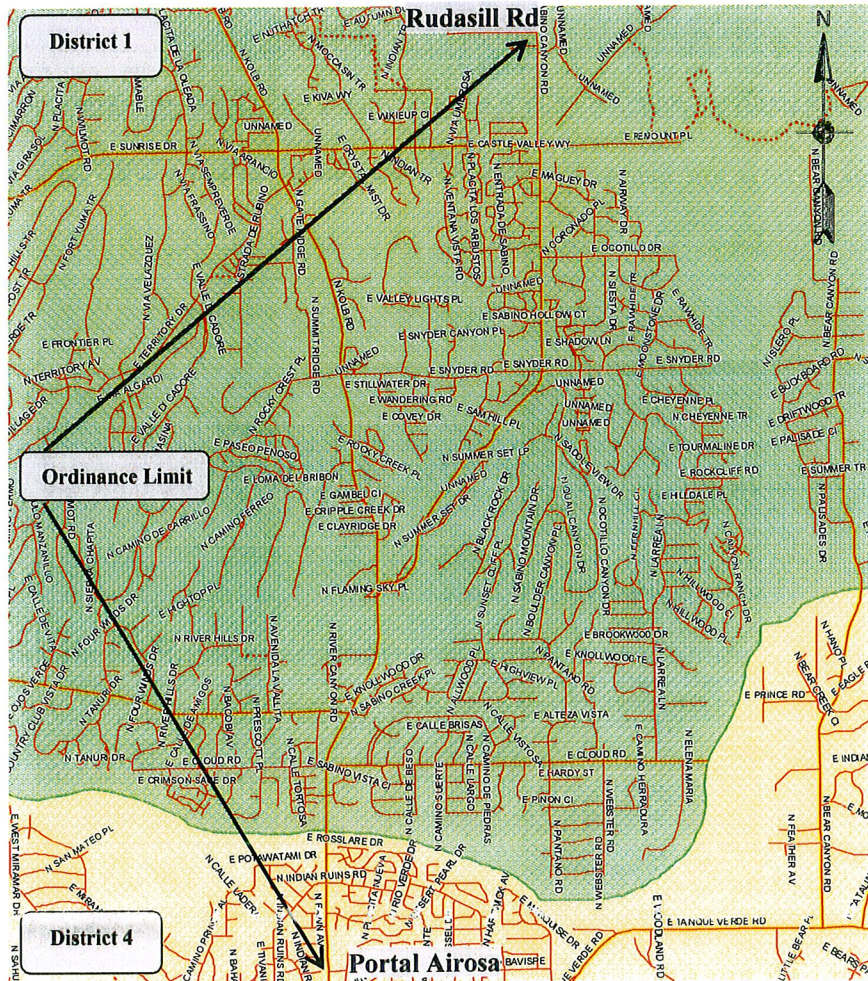

**ORDINANCE NO. 2013-\_\_**

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF  
SUPERVISORS REGULATING PARKING ON SABINO  
CANYON ROAD IN PIMA COUNTY, ARIZONA**

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not park anytime on Sabino Canyon Road from 340-feet north of Portal Airosa to Rudasill Road,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** Parking on the east and west side of Sabino Canyon Road from 340-feet north of Portal Airosa to Rudasill Road be regulated No Parking Anytime.

**SECTION 2.** Ordinances 1983-119, 1984-037 Section 1, 1985-014 and 2001-057 are repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflict.

**SECTION 3.** This ordinance shall take effect when and to the extent that signs are posted to on the highway herein listed giving notice of the parking restriction.

**SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

**SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


