*Title:

Attractions & Tourism Outside Agency Funding FY 2024-2025

*Introduction/Background:

The Outside Agency Program provides financial support to non-profit community agencies that collaborate with the County to provide economic development and improve and celebrate tourism and quality of life for area residents and visitors. Funding assists events, celebrations and programs which support tourism in Pima County. Prior to funding recommendations, each agency and/or program is reviewed for both programmatic and financial performance, contract compliance and potential risk. The total Outside Agency 2nd-year funding recommendation for FY 2024-2025 is \$400,000.00.

*Discussion:

The Attractions & Tourism Department solicited non-profits to apply for funding to be reviewed and awarded by the Outside Agency Citizen Review Committee for FY 2023-2024. The Outside Agency Citizen Review Committee convened on May 22nd and 23rd, 2023 and recommended 1st-year funding in the total amount of \$400,000.00*. *Board of Supervisors awarded a one-time-only \$20,000 request from the African American Museum of Southern Arizona increasing the initial award of \$400,000.00 to \$420,000.00.

*Conclusion:

The Attractions & Tourism Outside Agency Program compliments and expands services provided directly by the County.

*Recommendation:

It is recommended the Board of Supervisors approve the attached list of FY 2024-2025 Attractions & Tourism Outside Agencies' 2nd Year funding in the total amount of \$400,000.00 for the Attractions & Tourism Outside Agency Program and authorize the Chair of the Board of Supervisors to sign funding contracts with each of the agencies listed.

Re: FY 2024-25 RECOMMENDATIONS FOR OUTSIDE AGENCY PROGRAM – YEAR-TWO FUNDING

Background

The Outside Agency Citizen Review Committee (the Committee) is a panel of six members appointed by the Board of Supervisors (BOS) and County Administrator to serve as their representatives. The Community and Workforce Development (CWD) staff this Committee along with staff from the Pima County Department of Attractions & Tourism (A&T). Duties and responsibilities of the Committee are to review and make funding recommendations on A&T supported Outside Agencies (OA), which services include hospitality, attraction venues and tours, event settings, accommodations, food and beverages, souvenir sales, sporting events and community art integration for tourists and residents. Upon request, the Committee also reviews and makes recommendations for other County departments that administer and contract OA funds for BOS consideration.

Discussion

Outside Agency funds are made available on a two-year funding cycle. In FY 2023-24, A&T issued the current bi-annual Request for Proposals, via the ZoomGrants online application system. Per the two-year OA process, FY 2024-25 is considered the "off cycle year" where previous year agencies do not re-apply for funding. Still, the Committee reviews the progress of all funded programs and invites specific agencies to make presentations if there are any programmatic, fiscal, or contractual issues that may require further assessment, discussion, or recommendations to staff to provide technical assistance. Pursuant to special requests or circumstances, the Committee assumed level funding for the OA Program for the Pima County FY 2023-24 Budget.

For FY 2023-24 OA funds, the Committee held two open public meetings in May 2023. Agencies made presentations to the Committee to discuss the progress of their new or existing programs, in addition to, a review of their respective budgets and contractual obligations. Special requests, as appropriate, are also considered. Such was the case when the BOS awarded a one-time-only \$20,000 request from the African American Museum of Southern Arizona.

FY 2024-25 OA Committee Recommendations

Currently, the Committee is recommending year two, FY 2024-25 OA funds to twenty-two (22) agencies totaling \$400,000.00.

Conclusion

The Outside Agency Citizen Review Committee employs a public process that is community based and transparent; it is an extraordinary practice. Each Committee member recognizes their individual responsibility to evaluate the community needs of Pima County to make informed, appropriate, and reasonable recommendations to the BOS for valued OA resources. The Committee has embraced the use of the ZoomGrants online application, which has significantly improved and added efficiency to OA review and monitoring process. Finally, the Committee would like to thank the CWD staff for their community knowledge and expertise in supporting the OA Committee's mission and purpose.
