# Court mediators help reduce caseload

Going through litigation can be expensive and time consuming, whether it's a small claims lawsuit, an eviction, civil lawsuit or an injunction against harassment.

The staff at the Green Valley Justice Court hopes the recent expansion of their mediation program will mitigate those drawbacks.

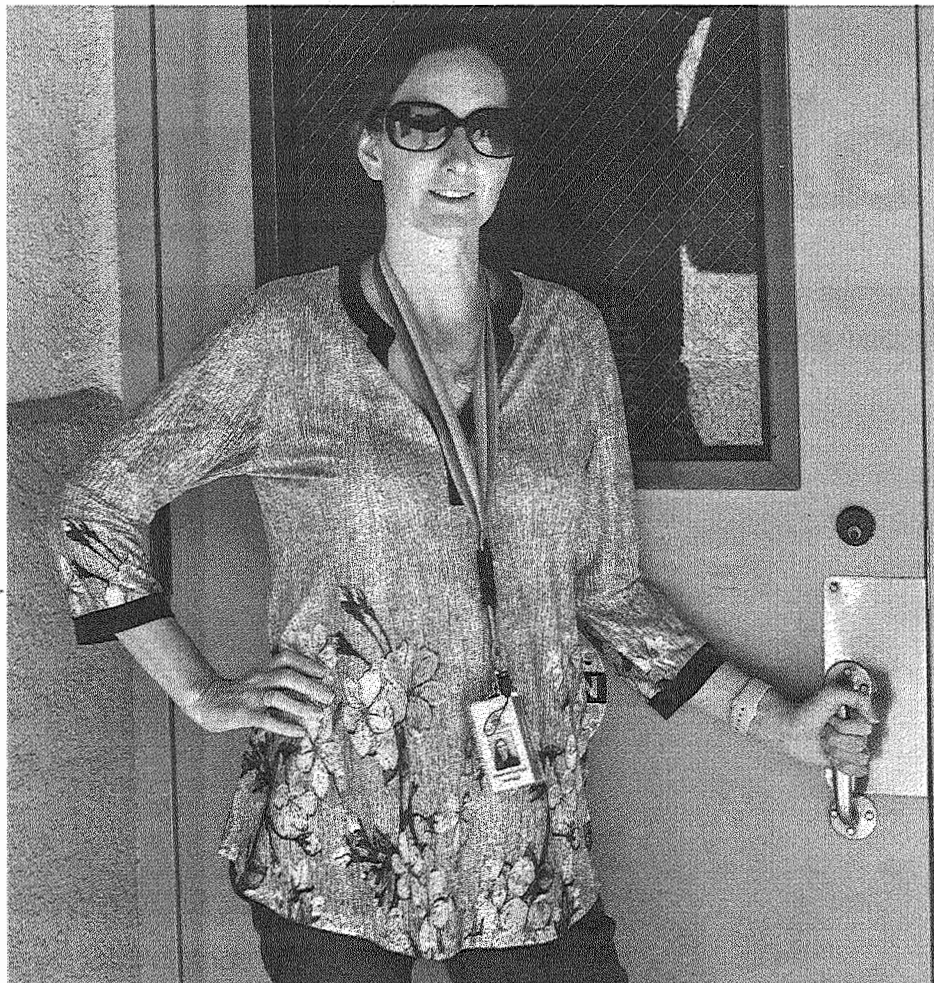
In recent weeks, five court staff members have been trained and certified as mediators by the Arizona Attorney General's Office.

As a result, when people come into the courthouse to file a lawsuit, an injunction or an eviction, they'll be offered the option to go through mediation instead. The other side will then be contacted to see if they're willing to participate.

"They're in charge of the process. They're in control. A mediator is not a judge. We build empathy between people. We facilitate conversations. We help get through some roadblocks in the communication process. It's usually on the parties to kind of come up with solutions and sort of bandy back and forth about what they're looking for," Court Administrator Kristen Randall said.

The mediators, who did a lot of observing and role playing, have all been trained on de-escalation techniques.

Should either party later renege on their agreement, the parties can go ahead and pursue litigation, Randall said.

"So there's really no risk, but there's a lot of rewards," she said. "They don't have to go to court...and it doesn't have the expense or the stress of court."

It also takes the power normally given to the judge and gives it to the parties involved, she said.

While the court already has two volunteer mediators who work Mondays, the

number of civil cases filed with the court are on the rise, Randall said. The justice court serves Green Valley, Sahuarita, Corona de Tucson, Arivaca, Amado and Sasabe.

Nearly 1,100 cases have been filed this year that could benefit from mediation if the parties agreed, Randall said. The two volunteer mediators are handling about three cases a week so

with five more, the chances of resolving cases increases significantly, she said.

A significant portion of the small claims lawsuits filed pertain to credit card debt of up to \$9,999, Randall said. Through mediation, people could theoretically cut down their fines and fees and create payment plans.

The court also handles a large number of neigh-

bor disputes that turn into injunctions against harassment, civil lawsuits and sometimes criminal charges, she said.

If mediators are successful in getting neighbors on the same page, it would save the court and the parties a lot of time and money, Randall said.

"The thing with mediation... is you are trying to build that empathy and that communication and also create a forum where you build understanding. You're kind of training people to talk to each other and if that fails, then they know that they have a place to come back to work out further issues," Randall said. "You're also building faith and that could reduce dueling orders of protection, that can reduce small claims turning into a civil suit and it can reduce the potential for citations."

The new mediators will schedule their sessions around their other obligations, she said.

The court will use special revenue funds to turn a portion of the former health department complex into a cozy space that will be used by the mediators and the county attorney's office when they need to meet with crime victims, she said.

"I just want to buy some inexpensive but brightly colored furniture so it doesn't look like a doctor's office or a courtroom," Randall said.

Special revenue funds are those collected by the court from fines and fees and can be used for items not covered by the general

fund, she said.

Margarita Valle, court office manager, took the 40-hour class because she wanted to be more helpful to Justice of the Peace Ray Carroll.

Valle said the class was interactive and she was surprised to learn mediators aren't expected to provide solutions to their problems, they're simply supposed to ask questions that will help the parties find their own solutions.

She plans to watch the first couple of mediation sessions before jumping in and will be "ecstatic" once her first case is successfully resolved, Valle said.

Carroll called it "a great addition to the services we provide."

Randall said she hears of cases every day she believes would benefit from mediation. Just recently, she read a Green Valley News story about a resident who is threatening to sue Pima County over a disagreement involving access to the Anza Trail near Abrego Drive and Continental Road.

"This is a perfect mediation opportunity," Randall said. "We would love the opportunity to help mediate. The worst-case scenario is that it just proceeds to litigation. It would be a challenge because there are people who are dug in, they're not going to move, but sometimes with mediation, each person can get something rather than both people getting nothing."

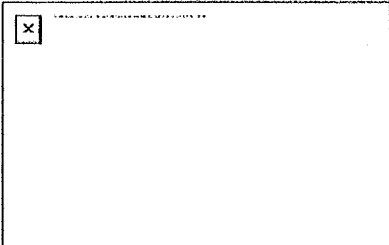


