Title: Temporary Road Closure Resolution

Introduction/Background:

The Perimeter Bicycling Association of America has requested the temporary closure of portions of Alvernon Way/ Aerospace Parkway/Hughes Access Road between Los Reales Road and Nogales Highway for the annual El Tour De Tucson on Saturday, November 19, 2016 from 7:00 A.M. to 12:00 P.M.

Discussion:

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour routes if needed due to inclement weather or other circumstances, are recommended to facilitate the event.
