**\*Title:**

Exchange of property between Pima County and the Pima County Flood Control District

**\*Introduction/Background:**

In 2017 the Board of Supervisors authorized an exchange agreement ("2017 Agreement") between Pima County ("County") and the Pima County Flood Control District ("District"). That Agreement identified 1,447 acres to be conveyed to the District from the County. A post action review of the properties approved for exchange in the 2017 Agreement revealed that certain parcels should have been split with only portions transferred rather than the full parcel being described and transferred to the District. That review also identified additional County properties better suited to be managed by the District and other property vested in the District better suited to be managed by the County.

**\*Discussion:**

Some of the properties conveyed to the District in 2017 have already been reconveyed back to County to conform with the terms of the 2017 Agreement. The remainder of the properties that are currently identified on the attached spreadsheet are in the process of being legally described and if required they will be surveyed as part of the exchange. The post action review identified additional net area of approximately 385 acres of flood prone land to be transferred to the District with the County receiving land and improvements in exchange from the District. The exchange has been determined to be substantially equal in value and no funds will be part of the transaction.

**\*Conclusion:**

The purpose of this action is to split and exchange real property assets for more efficient management of the land by either the County and the District. Property will be legally described and title to the land will be transferred between the County and the District for better management of those real property assets.

**\*Recommendation:**

Staff recommends approval of the actions outlined above.

**\*Fiscal Impact:**

The value of the land proposed to be transferred between the agencies has been estimated to be of substantially equal value.
