According to the latest findings from the Arizona Developmental Disabilities Surveillance Program (ADDSP), About 1 in 40 8-year-old children in an area of Arizona were identified with ASD.

PROCLAMATION

WHEREAS, Autism Spectrum Disorder (ASD) is a complex, lifelong developmental condition that typically appears during early childhood and can impact a person's social skills, communications, relationships and self-regulation. The autism experience is different for everyone. It is defined by a set of behaviors and is often referred to as a "spectrum condition" that affects people differently and to varying degrees. According to the latest findings from the Arizona Developmental Disabilities Surveillance Program, about 1 in 40 8-year-old children in a region of Arizona were identified with ASD; and

WHEREAS, during the month of April, we are recognizing individuals and families affected by ASD in Southern Arizona. We are dedicated to promoting autism acceptance, inclusion and self-determination for autistic individuals. Individuals with ASD should be given equal opportunities to achieve their highest potential; and

WHEREAS, since 1992, the Autism Society of Southern Arizona and its affiliates have led our communities to increase awareness and offer support, education, resources, advocacy, programs, information and referrals; and

WHEREAS, shining a light on ASD can provide new opportunities for Pima County to consider how it can pave the way for acceptance. Acceptance is often one of the biggest barriers to being valued and finding and developing a strong support system; and

WHEREAS, fostering acceptance is critically important to improving opportunities in education, employment, accessible housing, affordable health care and comprehensive long-term services and support. Learning a child's developmental milestones and understanding the signs of ASD are imperative for families. Early intervention services from birth to age 3 can lead to improved outcomes for children with autism; and

WHEREAS, through increased acceptance, we can build an inclusive society where individuals with autism live fully through connection and opportunity.

NOW, THEREFORE, BE IT RESOLVED that the Pima County Board of Supervisors hereby proclaims the month of April 2022 to be:

"AUTISM ACCEPTANCE MONTH IN PIMA COUNTY"
