*Project Title/Description:

Portable Restroom Rental and Services

*Purpose:

Amendment of Award: Master Agreement No. MA-PO-21-106, Amendment No. 04. This Amendment increases the annual award amount by \$150,000.00 from \$250,000.00 to \$400,000.00 for a cumulative not-to-exceed contract amount of \$800,000.00. Administering Department: Facilities Management.

*Procurement Method:

Pursuant to Pima County Procurement Code 11.12.010, Competitive sealed bidding, on 12/14/2020, the Procurement Director approved an award of contract for an initial term of one (1) year and annual award amount of \$150,000.00 with four (4) one-year renewal options.

Effective 03/14/2022, the Procurement Officer processed Amendment No. 01, which extended the termination date to 03/13/2023 and added the annual award amount of \$150,000.00 for a cumulative not-to-exceed contract amount of \$300,000.00. Three (3) renewal options remained.

On 01/24/2023, the Procurement Director approved Amendment No. 02, which increased the annual award amount by \$100,000.00 from \$150,000.00 to \$250,000.00 for a cumulative not-to-exceed contract amount of \$400,000.00.

Effective 03/14/2023, the Procurement Officer processed Amendment No. 03, which extended the termination date to 03/13/2024 and added the annual award amount of \$250,000.00 for a cumulative not-to-exceed contract amount of \$650,000.00. Two (2) renewal options remained.

This increase is due to greater requirements for portable restrooms and showers at the Drexel facility in support of southwest border operations providing essential humanitarian assistance to asylum seekers.
