Title: Temporary Road Closure Resolution

Introduction/Background:

The Perimeter Bicycling Association of America has requested the temporary closure of portions of Alvernon Way/Alvernon Way Extension/Aerospace Parkway/Hughes Access Road between Los Reales Road and Nogales Highway for the El Tour De Tucson on Saturday, November 21, 2015 from 7:00 A.M. to 12:00 P.M.

Discussion:

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour routes, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

Conclusion:

Pima County Traffic Engineering recommends the temporary closure of portions of Alvernon Way/Alvernon Way Extension/Aerospace Parkway/ Hughes Access Road between Los Reales Road and Nogales Highway to enhance the safety of the El Tour De Tucson event by reducing potential vehicular conflicts.
