LEASE AMENDMENT

WHEREAS, COUNTY and TENANT entered into a Lease Agreement to lease the Berger House as referenced above; and

WHEREAS, TENANT and COUNTY, pursuant to Article 6 – Improvements to Premises, have agreed to certain capital improvements to allow for Tucson Girls Chorus program expansion.

NOW, THEREFORE, the parties agree as follows:

Tenant has proposed to make certain capital improvements, specifically renovations of one of the existing restrooms. Tenant will assume all financial responsibility for interior renovations.

In addition, County and Tenant have agreed to connect the second bathroom that is currently on septic to the county's sewer system. The sewer connection is estimated to cost Twelve Thousand Dollars (\$12,000.00) (the "Initial Estimate"). County and Tenant have agreed to a 50/50 cost share of the final sewer connection cost. Within ten (10) days of amendment ratification Tenant agrees to submit a first lump sum payment of Five Thousand Dollars (\$5,000.00) to Pima County. Upon completion of construction, Tenant shall pay its additional share of actual construction costs, if any, ("Final Costs") as follows: If Final Costs exceed the Initial Estimate Tenant will be sent an invoice for Tenant's share of the increased cost and Tenant agrees to pay the invoice within thirty (30) days of receipt. If final costs are less than the Initial Estimate County will issue Tenant a refund or Tenant may choose to have County apply the refund toward quarterly rent.

The effective date of this Amendment shall be November 4, 2014.

All other provisions of the Lease, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.




