**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

The Perimeter Bicycling Association of America has requested the temporary closure of portions of Silverbell Road between Ina Road and Sweetwater Drive for the annual El Tour De Tucson on Saturday, November 21, 2015 from 8:00 A.M. to 5:00 P.M.

**Discussion:**

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour routes, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

**Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions of Silverbell Road between Ina Road and Sweetwater Drive to enhance the safety of the El Tour De Tucson event by reducing potential vehicular conflicts.

Staff recommends approval of this resolution to temporarily close a portion of Silverbell Road for the El Tour De Tucson on November 21, 2015 from 8:00 A.M. to 5:00 P.M.


