Dear Supervisors:

I understand that last year's approved budget was \$1.9 billion, and this year's would be reduced to around \$1.8 billion. On the surface, this seems to be a significant reduction, but unfortunately, this is not the case. There is a \$265 plus million deficit along with another proposed property tax hike, so harmful in this time of inflation. If the proposed budget and debt service are approved, do you realize that Pima will be bankrupt within a few years unless property taxes are hiked again significantly? Why approve ANY debt service? Look at Maricopa County's projected budget. It's around \$4.462 billion with a property tax **decrease** for a population of over 4 million people compared to Pima's estimated 1.5 million. Pima's budget needs tightening before it's approved. Property owners are tired of footing the bill.
