**RESOLUTION NO. 2013 – \_\_\_\_\_**

RESOLUTION OF THE BOARD OF SUPERVISORS OF PIMA COUNTY ARIZONA, REDESIGNATING THE COMMUNITY OF SIERRITA MOUNTAIN AS A COLONIA IN UNINCORPORATED PIMA COUNTY AND AUTHORIZING THE COMMUNITY DEVELOPMENT AND NEIGHBORHOOD CONSERVATION DEPARTMENT TO APPLY FOR FUNDS FROM THE FY 2012/2013 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM COLONIAS SET ASIDE FROM THE ARIZONA DEPARTMENT OF HOUSING

WHEREAS, Section 916 of the Cranston-Gonzalez Act of 1990 as amended ("the Act") defines a "colonia" as an identifiable community:

1. Within 150 miles of the U.S.-Mexican Border;
2. Designated by the State or County as a "colonia";
3. Lacks a potable water supply, adequate sewage systems, and/or decent, safe, and sanitary housing; and
4. In existence and generally recognized as a colonia before November 28, 1990; and

WHEREAS, in compliance with the Act, the Community of Sierrita Mountain has consistently been certified as a colonia by Pima County and recognized as such by both the U.S. Department of Agriculture and the U.S. Department of Housing and Urban Development; and

WHEREAS, the Arizona Department of Housing ("ADOH") will allocate funds from the FY 2012/2013 Community Development Block Grant ("CDBG") Colonias Set-Aside for activities that will meet the needs of colonias in Arizona; and

WHEREAS, Pima County will apply for CDBG Colonias Set-Aside funds from ADOH for projects that will address the needs in the Community of Sierrita Mountain that are eligible for such funds; and

WHEREAS, ADOH requires that an applicant requesting CDBG Colonias Set-Aside funds adopt a Resolution certifying that the area meets the Section 916 definition; and

WHEREAS, the Pima County Board of Supervisors finds and certifies that the Community of Sierrita Mountain in unincorporated Pima County is a "colonia" with continuing water, sewer and/or housing needs that are eligible to be funded through the ADOH CDBG Colonias Set-Aside.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of Pima County as follows:

1. The Community of Sierrita Mountain is again certified to be a "colonia" as defined by the Act. Sierrita Mountain is identified on the map attached hereto as Exhibit A and generally described as follows:

Entire community of Sierrita Mountain as shown on attached map. Enclosed within Arizona State Highway 86 to the North; McGee Ranch Road to the South; Sandario Road, an unmarked road, and Starlight Canyon Trail to the East; and, Arizona State Highway 286 to the West.

Sierrita Mountain is 114 square miles and approximately 33 miles from the U.S.-Mexico Border.

2. That the Community of Sierrita Mountain has been recognized by Pima County as an area that lacked adequate potable water supply, adequate sewage system, adequate roads and drainage, and sanitary, safe and decent housing prior to the Act and continues to be without some of these amenities.
3. That the Community Development and Neighborhood Conservation Department is directed to complete, and submit to ADOH, an application to secure CDBG Colonias Set-Aside funding for activities that will address the specific needs in this Colonia.
