RELATING TO BOARDS, COMMISSIONS AND COMMITTEES; APPOINTING RAYMOND COPENHAVER AS THE TOWN OF MARANA CITIZEN REPRESENTATIVE TO THE TUCSON - PIMA COUNTY BICYCLE ADVISORY COMMITTEE

WHEREAS the Tucson - Pima County Bicycle Advisory Committee (TPCBAC) was established to serve in an advisory capacity to local governments on issues relating to bicycle recreation, transportation, and safety; and

WHEREAS the Town of Marana is a member of the Tucson – Pima County Bicycle Advisory Committee; and


