

WHEREAS, the programs of Literacy Connects provide learners of all ages with opportunities to realize their full potential – at school and in the workplace, as parents, as consumers, and as participants in the cultures of our community; and

WHEREAS, the programs of Literacy Connects coach children in reading so they can perform more successfully in the classroom and help adults with reading, writing, math, and English skills; and

WHEREAS, these programs encourage parents to recognize the importance of reading to their children, help young people experience the power of words and ideas through the arts, and put books in the hands of people who need them; and

WHEREAS, in the last year Literacy Connects staff members and more than 1,000 volunteers helped close to 50,000 Southern Arizonans gain and improve their skills in these critical areas; and

WHEREAS, Literacy Connects continues to work with limited funds at its facility located at 200 East Yavapai Road so it can better serve its clients; and

WHEREAS, the Thomas R. Brown Family Foundation recently provided Literacy Connects with a generous financial contribution that has enabled it to repave its parking lot and renovate three spaces for classrooms; and

WHEREAS, these improvements will enable Literacy Connects to increase its services by offering more English and literacy classes for adults, and to launch Family Reading Nights, intergenerational nights of food, family, fun and reading;
