Re: Appointment of Pima County Public Defender and Legal Defender

The Public Defender and Legal Defender positions have both recently become vacant; the first due to the promotion of former Public Defender Lori Lefferts to Director of the Public Defense Services Department, and the second as a result of the retirement of former Legal Defender Isabel Garcia. I directed that both positions be open to applications from the public and that a committee be formed to conduct interviews and make recommendations to me. The positions were subsequently publicized on the County jobs website, through the Arizona Attorneys for Criminal Justice, the Arizona Public Defenders Association, and the Arizona Minority Bar Association; and advertisements were published in the Arizona Daily Star and Arizona Republic, as well as on an online jobs website.

A total of 21 attorneys applied, of whom 18 applied to be Legal Defender and 12 to be Public Defender, with 9 of the total applying for both positions. The selection committee included Ms. Lefferts; Assistant Pima County Administrator Ellen Wheeler; criminal defense attorney Jim Stuehringer, a partner with the Tucson law firm of Waterfall, Economidis, Caldwell, Hanshaw & Villamana, PC; and Maricopa County Public Defender Jim Haas. The committee selected a diverse pool of nine candidates for interviews.

<u>Public Defender.</u> The committee has recommended the appointment of Mr. Steve Sonenberg to Pima County Public Defender. Mr. Sonenberg has been serving as Interim Public Defender since May, he has been an attorney with the Public Defender's Office for 20 years, and he has served as Chief Assistant Public Defender for three years. Prior to becoming Chief Assistant, he was a trial team leader, supervising 15 attorneys and 8 support staff. Mr. Sonenberg practiced criminal defense law in the Detroit area for approximately 16 years before joining the Pima County Public Defender. His resume is Attachment 1 to this memorandum.

I concur with the selection committee's recommendation to appoint Mr. Sonenberg to the position of Public Defender, and I will be placing this issue on the Board of Supervisors August 17, 2015 agenda for Board consideration and ratification.

<u>Legal Defender</u>. Based on my concurrence with the recommendation of the selection committee, I am appointing Assistant Public Defender Dean Brault to Legal Defender. Mr.

Brault has been an attorney with the Public Defender's Office since 1997, and he has been a trial team supervisor since March 2012. In that capacity, he has supervised 15 lawyers, four secretaries and four legal assistants. He was named Attorney of the Year by the Arizona Public Defender Association in 2003.
