Pima County Board of Supervisors,

I am writing in favor of the proposed Bike Ranch Resort near Saguaro National Park East.

After reviewing the developer's website, including letters from neighbors in opposition, the only justifiable action is to approve this project. The developer is clearly willing to meet the rightly stringent development restrictions. What better use of this neglected parcel can we expect anytime soon?

The existing buildings have been an unsightly mess for years. Many areas of Pima County are still in transition from such ramshackle neighborhoods to the progressive desert community that has garnered international praise. Denying this attractive development would unduly hold back our progress.

Those opposing the development, including the Park Service, offer nothing but the standard, self-serving reasons: Increased traffic would be inconvenient. The peace and quite of bygone years would be compromised. Such people oppose diversity and growth as a thoughtless reaction. The "not in my backyard" attitude is understandable; but it cannot be enforced by the Pima County Board of Supervisors, which is responsible to the whole community.

I have read with interest the pros and cons of the proposed Bike Ranch development on Old Spanish Trail across from Saguaro National Park. I am writing this letter as a resident of east Tucson and frequent visitor to Saguaro National Park to encourage you to approve the Bike Ranch development. I believe you will arrive at the same conclusion as I have once you realize that it is not realistic to expect anyone to own and pay taxes on 45 acres of land without developing it into an asset for that owner. In light of that reality, the Bike Ranch appears to be a rare opportunity to minimize negative effects of development while allowing use of the property within the limits already established by the Buffer Overlay Zone Ordinance.

The most remarkable unfavorable comment I have read is the one from the Saguaro National Park Superintendent, so I'll address it first. In his memorandum, he says he opposes the bike ranch for several reasons, among them, "the Bike Ranch would certainly infuse additional numbers of high speed bicyclists onto the Loop Drive, increasing the likelihood of visitor use conflicts and safety concerns." His statement implies that the park already has all the visitors he wants it to have or that he is of the opinion that motor traffic is somehow less damaging to the desert than bicycle traffic. He points out that more visitors would increase the likelihood of conflicts and his plan for reducing conflicts is to avoid enticing more people to visit. It seems to me that we all agree that the Bike Ranch will be a boon to Saguaro National Park visitation numbers and the commissioner should welcome the opportunity to address any issues that increased patronage might generate.

His comment that the development is incompatible with the park's goal of preserving "pristine stands of saguaro cacti and associated diverse Sonoran Desert vegetation and wildlife" would be germane if the development was proposed in the park, but it is not. He expressed concern about the impact of the Bike Ranch on the vistas seen from within the park, and the traffic the Bike Ranch might create outside the park. The impact of the Bike Ranch must be measured against the alternative of 13 single family homes, not against the current condition of undeveloped land. I can't see how 13 individual homes can be expected to be any better for the vistas than a coherent development under the influence of a single architect. The wild life corridors have been identified and protected within the Bike Ranch plan, and will be much easier to defend with a single property owner than would be possible with 13 single family dwellings.

The debate about the development of the Bike Ranch seems to be easily led off track by a resistance to any development at all. Like many others, I'd really rather the land remain undeveloped and/or be annexed to Saguaro National Park, but that is not an option. Once we accept the idea that the land will be developed in some manor, it is hard to imagine a

development that will have less impact in terms of traffic, noise, pollution, or lifestyle on the east side of Tucson while increasing cash flow into the community.

It is generally accepted that Tucson needs to bring in more tourist dollars and grow jobs in our area. That means bringing people into our community and that typically means people who drive around to entertain themselves. This is a unique opportunity to bring in revenue with the least imaginable addition of motor traffic on our roads here on the east side of Tucson. In operation, the Bike Ranch will add almost no noise or air pollution to our area, and very little infrastructure needs to be built. The trails and bike lanes are already in place. Bicycles already travel these routes in large numbers without adding to our noise or air pollution.

Please keep in mind that you are not being asked if you think the Bike Ranch proposal is better than “pristine stands of saguaro cacti and associated diverse Sonoran Desert vegetation and wildlife.” You are being asked if the development is responsibly planned within the limitations established in the Buffer Overlay Zone Ordinance, and is it in the best interest of the community. Any other development scheme will surely have a more damaging impact on noise, traffic, air pollution and quality of life here on the east side of Tucson. This is a development proposal that we should support. It is the best way for us to address our economic imperatives while we defend our serene desert lifestyle.



This is a letter in opposition to the proposal, which will be addressed at a Board meeting on Nov. 18, by company that intends to build a bicycle hotel/resort on property that is at the very edge of Saguaro National Park East.

This proposed commercial bicycle resort and hotel, and its associated traffic and commercialism at the lip of Saguaro National Park-East, will have adverse effects on property and cultural values in the Notch, a neighborhood that borders the Park and takes seriously its role as a buffer zone for the Park.

The bicycle resort -- with lots of outdoor lighting and automobile traffic -- would also adversely affect our valued "Dark Skies," both in the Notch and in Saguaro National Park.

Tucson -- the headquarters of the International Dark Skies Association -- is admired nationally, among astronomers, environmentalists, urban planners and even business interests, for its respect for dark skies. Allowing this resort to build and expand on the very border Saguaro National Park -- a place where you can still see the Milky Way in the skies -- would be a direct affront to those values.

Allowing this development could very likely become a national story in the media as well, as an example of a city that is losing ground (or sky) in protecting environmental and cultural values.

I am extremely supportive of the proposed "Bike Ranch" resort at 3700 S. Old Spanish Trail. As an equine veterinarian, horse woman and neighbor I feel uniquely qualified to address some of the concerns expressed by the Saguaro Horsemen's Association.

The first concern is that "bicycles and horses don't mix." It is indeed true that a group of bicycles silently zooming past a horse can have dire results. Unfortunately, most cyclists have no idea how to safely approach a horse and rider. That is why every guest of the Bike Ranch will receive training, not only in Arizona biking laws and etiquette, but in the best way to approach and pass a horse. They will learn to slow down and call out, "Good morning – passing on your left." This gives the rider the opportunity to stop and turn toward the bicyclist. The horse is not startled, stands quietly, and there are no dire results. I'm thrilled that all Bike Ranch guests will be excellent role models for other cyclists in Tucson as well as bikers in their home towns, and countries.

Another concern is that there will be an increase in close encounters between horses and cyclists. I ride in Saguaro National Park East frequently using the "multi-use trails" such as Shantz, Vanover, and Pink Hill and have never encountered a bicyclist. In several areas the trails are narrow and deep – it would be impossible for cyclists to use the same trails commonly used by horseback riders and hikers in the park. The cyclists in Saguaro National Park share the roads with cars, not horses.

The Saguaro Horsemen's Association expressed concerns regarding a dramatic increase in bicycle traffic on roads surrounding and within the park. This will be minimal. Guests of the Bike Ranch, many professional cyclists, will be training on

Mt. Lemmon, the Colossal Cave trails, Cat-D trail in Redington and the Arizona Trail. The Bike Ranch will not significantly increase bike traffic within the park. An increase of 6-10 cyclists per day is expected. "The Loop", the 130 mile system of shared use paths encircling Tucson, will bring many times that number of cyclists to Saguaro National Park East each day.

I understand the concerns regarding wildlife and the desire to preserve wildlife habitats. As a veterinarian and past Medical Director of the Tucson Wildlife Center, I feel confident that our wildlife population will not be adversely affected by the Bike Ranch. Wildlife migration corridors have been studied and will be preserved. Wildlife have strong survival instincts and are extremely adaptable to changes in the environment. The plan for the Bike Ranch includes clusters of buildings leaving more than 70% of the 45 acres untouched. Approximately 32 acres will be left open and undisturbed. There will be no fences. Coyotes, bobcats, and javelina will be free to roam as they please. Any rattlesnake that is found within the cluster of Bike Ranch buildings will be humanely caught and relocated to nearby areas in which rattlesnakes currently live and thrive.

I have spent considerable time with the developers of the Bike Ranch, Peter Lasher and Kelley Matthews, asking questions and reviewing their business and building plans. I am convinced that the concerns of the Saguaro Horsemen's Association are unfounded. The Bike Ranch will be a positive addition to our community and to Tucson. It will help to stimulate our stagnant economy, create jobs, and promote Tucson as a premier biking destination. I hope you agree and approve the Bike Ranch development.

Tucson has recently enlarged and widened many of its roads to add bigger and better bike lanes. This action was taken by both the City and County.

Now that we have these bike lanes, why is there a problem with the building and opening of a Biker Guest Ranch on the far, East side of town? This Ranch will have 45 acres and leave 83% as natural open space and will use the remaining acres to build the Ranch.



Honorable Supervisors,

We **strongly object** to the granting of a conditional use permit allowing the construction of a commercial 'Bike Ranch' on Old Spanish Trail opposite the entrance to Saguaro National Park. We own and reside full time on Old Spanish Trail approximately one-half mile north of the proposed site of the Bike Ranch at 3700 S. Old Spanish Trail. We purchased this property in 2005 and moved here for the nature of the neighborhood: low-density private homes, near a protected national reserve, and no contemporary commercial development. Having first investigated the Buffer Overlay Zone Ordinance, we felt that the character of the area surrounding the National Park was adequately protected from unwanted development.

Our objections are twofold: first, if a conditional use permit is granted and the Bike Ranch constructed, this will effectively nullify the Buffer Overlay Zone Ordinance and will remove or severely weaken any legal authority for denying further commercial development in the area. The National Park could be subject to further unlimited objectionable development within close sight of the park and this is extremely detrimental to the purpose of the National Park. Second, the business plan for the Bike Ranch is questionable. Should the business fail after construction, the site will be left with either an abandoned collection of buildings, or the site may be purchased by any other commercial venture. With the local zoning protection weakened, the nature of any subsequent business could be even less desirable for this critical location immediately opposite the Park entrance. The granting of the CUP and construction of this business is permanent and will forever damage the protections Pima County has admirably attempted to apply to the National Park.

- "protect the park" concerns, (regarding cycling traffic in the park, light pollution, precedent for other commercial development, compromised westward views)
- wildlife corridor concerns
- concern that cyclists are primarily responsible for road kill. Really.

The issues and proposed solutions I was anticipating hearing about were not objectively discussed and evaluated at this meeting. Rather, it had the atmosphere of a torch bearing mob, with the primary instigator being County Supervisor Ray Carroll. The behavior of the group opposed to the project was rude and offensive, and they refused to allow civil discussion of the issues. It all seemed to be well orchestrated, for reasons that Ray Carroll should be required to explain. Isn't there supposed to be at least the pretense of objectivity by elected officials in matters like this?

It's human nature to want the place one lives to remain unchanged, and the "not in my backyard" mentality is understandable. But fear of change should not be the influence that trumps every other consideration, even when presented with a fair amount of hysteria.

On my own, through visiting the Bike Ranch website and meeting with Peter Lasher and Kelley Matthews, I've determined that the project is well thought out, that all valid concerns are being addressed responsibly, and that it will be a first class resort that will further enhance Tucson's image as a cycling mecca.

I moved my family from Boulder, CO to Tucson twelve years ago. We love Tucson, but during this time we've watched one amenity after another disappear, including Spring Training, AAA baseball, the Hidden Valley Inn, the old Triple C Chuckwagon, among others. Many of our favorite restaurants have closed, as well. The job situation in Tucson is terrible, and is recovering at a much slower pace than most



Dear Tucsonan,

I had one of those bizarre moments we have in life sometimes when I first heard of the Bike Ranch. I was having lunch with a friend of mine and we were trying to brainstorm where best to house a group of athletes coming to Tucson to train for the upcoming Kona Ironman. My friend is a world class triathlete and coach to a growing number of Ironman hopefuls. One challenge was establishing lodgings and accommodations for approximately two dozen athletes, their expensive bicycles, their extensive gear and their rigid dietary needs. The second challenge was finding a place with close proximity to Reddington Pass and Mt. Lemmon. It should be noted that my friend does not charge "Econo Lodge" rates and caters more to the resort type than the hotel type.

Miraval was too far and Canyon Ranch was unable/unwilling to house so many with so much baggage. As we eliminated options, I received the solution from the sky -in the form of a text from a friend informing me that Kelley Matthews was opening a classic style ranch for bicyclists. On the east side. Near Mt Lemmon and Reddington Pass. I showed the text to my friend, who said: "it's perfect, too bad it's not here already". It's not often that the solution to a problem falls into our laps, or inboxes.

There is a well kept secret about Tucson in that it is quickly becoming the residence of choice for world class triathletes. I personally know of six who have permanent homes here. My aforementioned friend is a professional athlete and coach, but also an entrepreneur who launched a clothing line specializing in swimming, cycling and running. Another friend is a previous Ironman and Canadian National Triathlon champion. When asked, they cite the weather and access to Mt Lemmon as primary motivation.

It is virtually impossible to drive the streets of Tucson without seeing the signs that this a community that embraces the growing sport of competitive cycling. The white elliptical bumper stickers with the numbers 70.3 or 140.6 (signifying half and full Ironman participation) are everywhere, and the streets are choked with teams of cyclists of all ages on the weekends. As a city, we can choose to embrace this growing trend, or act to alienate a potentially economy-changing industry. The development of The Bike Ranch would serve to advance the first, while allowing the blockage of it to serve the latter.

I have lived at the intersection of Houghton and Old Spanish Trail since the late 1990s. I remember when I first moved there, the thing that struck me most was the stars at night. They were numerous, clear and bright. As the years passed, the view became more and more limited as uninspired and ubiquitous commercial sprawl encroached: Target, McDonald's, Walmart, Walgreen's, Bed Bath & Beyond, etc. If it is the argument of the opposition that the east side should be saved from commercial development, they are years too late. The only hope now is the development of businesses that are unique, subtle and help to maintain the integrity of Tucson and its rich history and architecture. It seems that the Bike Ranch achieves all of these criteria and more. I would rather see 10 Bike Ranches than one more corporate monolith go up in my neighborhood. I would rather see my beloved hometown embrace an industry that is not about death and war making (such as Davis Monthan AFB and Raytheon). I would love to see a Tucson that has something unique to offer tourists, not just the same strip malls of the same boring and ugly businesses.

In short, The Bike Ranch seems like a no-brainer. To anyone, that is, with a brain. Please allow the building of The Bike Ranch and prove to Tucsonans that we have something to be optimistic about where our economy is concerned. Please do the right thing and embrace the future of our beautiful city.
