Chris Straub, Chief Civil Deputy County Attorney, stated the Board previously approved a settlement involving the acquisition of approximately 155.35 acres of real property controlled by the BSE Trust for a total compensation of \$1,000,000.00. The BSE Trust informed the County Attorney that it no longer believed it was the beneficiary of the trust, holding fee title to Tax Parcel Nos. 137-11-431D and 137-11-431G, totaling 0.78 acres. The BSE Trust instead provided a Quit Claim Deed to those parcels conveying them to the Pima County Flood Control District. He stated the County Administrator and County Attorney's Office recommended approval of the modification of the settlement and acceptance of the Quit Claim Deed for the

two parcels in lieu of condemnation. He stated the other terms of the settlement would remain the same.

It was moved by Supervisor Elías, seconded by Supervisor Miller and unanimously carried by a 5-0 vote, to accept the recommendation.
