ORDINANCE NO. 2014 - \_\_\_\_, An ordinance of the Pima County Board of Supervisors, regulating parking on Curtis Road in Pima County, Arizona. Staff recommends **APPROVAL**. (District <u>3</u>)

The reason for this ordinance is to restrict parking in the vicinity of Curtis Park and the Sporting Chance Center and to provide a safer crossing environment for pedestrians accessing these facilities.

It is recommended that both sides of Curtis Road be regulated No Parking from Kain Avenue to La Cholla Boulevard. At the request of Pima County Parks and Recreation officials, this ordinance will extend the existing parking restrictions to La Cholla Boulevard to improve visibility for pedestrians accessing Curtis Park and the Sporting Chance Center as well as drivers exiting the facility parking lots. In the interest of pedestrian safety, additional No Parking signs have already been installed.

# AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING PARKING ON CURTIS ROAD IN PIMA COUNTY, ARIZONA

**WHEREAS,** the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

**WHEREAS,** the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not park on certain portions of Curtis Road,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

- **SECTION 1.** Parking on both sides of Curtis Road from Kain Avenue to La Cholla Boulevard shall be regulated No Parking.
- **SECTION 2.** Ordinance 2006-024 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.
- **SECTION 3.** This ordinance shall take effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.
- **SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.
- **SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
