Title: Precinct Committeemen Appointments and Resignations

Precinct committeemen are elected at the primary election during each even-numbered year. According to A.R.S. section 16-821 B, if a vacancy exists in the office of precinct committeeman, the Board of Supervisors may fill the vacancy upon recommendation from the county chair of the appropriate political party. If a previously elected or appointed precinct committeeman resigns or moves from his or her precinct, a resignation is submitted by the party chair for approval by the Board of Supervisors and the position becomes vacant.
