Title: Yedra Road Through Street

## Introduction/Background:

The reason for this ordinance is to establish Yedra Road as a through street from 1,570 feet west of Barnhill Drive to Los Reales Road to allow for installation of effective traffic control.

#### Discussion:

Yedra Road from 1,570 feet west of Barnhill Drive to Los Reales Road is an east/west two lane median divided road that serves the Star Valley subdivision. A review of the local roads that intersect Yedra Road determined the need to establish an ordinance for effective traffic control at all side streets.

#### Conclusion:

Yedra Road is recommended to be established as a through street.

# AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS ESTABLISHING YEDRA ROAD AS A THROUGH STREET IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate through streets and erect stop or yield signs, and

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to designate Yedra Road as a through street,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

- **SECTION 1.** Yedra Road be designated as a through street from Los Reales Road to 1,570 feet west of Barnhill Drive.
- **SECTION 2.** All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.
- **SECTION 3.** This ordinance shall take effect when and to the extent that stop or yield signs are posted on the intersecting streets.
- **SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.
- **SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
