Dear Board of Supervisors,

I am writing to show my support for the JobPath program and the vital role they play in creating equitable access to education, job training, and economic opportunity in Pima County.

I have had the honor of serving on the Board of Directors for 7 years, 4 of which as Board President. I was introduced to JobPath when I was asked to speak to young high school students about the "Day in the Life" of an Engineer. I was immediately interested in the mission as my mother, Mary Hartl (Nee. Mary Ann Lemieux), an Army Nurse Veteran from Vietnam, was a Surgical Tech Instructor in my hometown of Racine, Wisconsin. I watched for years as the education her students learned served the community and got those families financial stability. Once I was introduced to JobPath, I found a way to serve my community in a way that emphasized education, broke the poverty cycle in multiple ways, gave the community the workers it needs, and continue my mother's legacy. In my time on the board, I have watched the program go from serving less than 200 students to over 600. The mission and quality of the programs has remained constant due to Ana Grief and her staff. The programs have expanded, in times of need, to give the students the stability they need to get through school and gain employment that is so desperately needed. Post Covid, JobPath has a variety of programs that supports students during their coursework and gives them useful skills to get and keep indemand jobs. As a small business owner in Tucson, I see the struggle for qualified technical candidates across aviation, automation, and applied technologies. As an asthmatic, I see and feel the need for qualified medical care givers. As an educator, I see how stabilizing the external concerns of a student enables them to focus on the coursework and complete their programs of study.
