To Pima County Board of Supervisors,

My name is Michael McMahon, and I reside at 10440 W. Massingale Rd. I am opposed to the proposed cell tower, P24CU00007 SWENSON, at 10510 W. Massingale Rd. I attended the Zoning & Planning Commission public hearing October 30, 2024. During the meeting one of the commissioners asked the representative of Vertical Bridge if there were any alternative sites for this project.

The Vertical Bridge representative said there were many sites considered but after their research all were eliminated except for the site on Massingale. Vertical Bridge stated there are no other wireless communication facilities within 2 miles of the proposed site.

Currently, there is a cell tower located at the Picture Rocks Fire Station, 7341 N. Sandario Rd. It is 1.9 miles from the site, measured from driving roads. A straight-line measurement would make it closer.

The Speedway gas station, 6890 N. Sandario Rd., is 2.5 miles from the site. Also measured from driving roads. A straight-line measurement would also make in even closer.

Northwest Fire District, Continental Ranch, 8115 N. Wade Rd. has 2 cell towers of equal height less than 100 yards apart.

If Vertical Bridge states there is a redundancy issue with the existing towers in Picture Rocks, wouldn't the same issue exist at the Continental Ranch Fire Station?

The proposed site would waste 180 degrees of range over the Saguaro National Park and quarry. Not a very efficient use of their resources.

Our community does not need an 8-story eyesore in the middle of the beautiful scenic view of Saguaro National Park. Nobody that I have talked to has any issues with their cell phone service and as I have stated above, there are towers already in place just down the road. This is about financial gain and greed, not about servicing the community

To whom it may concern:

I am the homeowner of 10440 W Massingale Rd, located across from 10510 W Massingale Rd. This letter is to voice my opposition to Vertical Bridge's proposed construction of a cell phone tower on 10510 W Massingale Rd.

As a direct neighbor to the proposed site, this construction project will harm my family, our community, and the surrounding environment while negatively impacting the wildlife and native species in the area. The proposed site is located in a Class D Regulated Riparian Habitat area and should be protected from this proposed project.

The erection of a cell phone tower in our neighborhood threatens the native species that have made this area their home.
