RESOLUTION AND ORDER NO. 2013 - ____OF THE PIMA COUNTY BOARD OF SUPERVISORS PROVIDING FOR THE VACATION BY EXCHANGE OF A PORTION OF SUNRISE AVENUE FOR THE FEE DEDICATION OF OTHER PUBLIC RIGHT OF WAY AS PIMA COUNTY ROAD ABANDONMENT NO. A-13-12 SITUATED WITHIN SECTION 16, TOWNSHIP 13 SOUTH, RANGE 13 EAST, G&SRM, PIMA COUNTY, ARIZONA

RECITALS

An application has been received by Pima County for the vacation to QuikTrip Corporation, an Oklahoma corporation, ("QuikTrip") of a portion of public road right-of-way known as Sunrise Avenue lying within Section 16, Township 13 South, Range 13 East, G&SRM, Pima County, Arizona, more particularly described in the attached **Exhibit "A"** and depicted in **Exhibit "A-1"** (the "Abandoned Property");

In exchange for the Abandoned Property, QuikTrip has conveyed to Pima County the property described in the attached **Exhibit "B"** and depicted in **Exhibit "B-1"** (the "Exchange Property").

The County has determined that the Abandoned Property is not needed for public use pursuant to Arizona Revised Statutes (A.R.S.) Section 28-7202; and

No land adjoining the Abandoned Property would be left without public or private legal access.

NOW THEREFORE, the Board of Supervisors of Pima County resolves as follows:

Section 1. That the Abandoned Property be vacated pursuant to A.R.S. § 28-7203.

<u>Section 2</u>. That this Resolution will become effective only in the event the Board of Supervisors approves the development plan for QuikTrip under File No. P13DC00007 for the property surrounding and including this vacation.

Section 3. The Chairman of the Board of Supervisors is hereby authorized to execute a Quit Claim Deed to QuikTrip for the Abandoned Property upon this Resolution becoming effective.
