ITEM SUMMARY, JUSTIFICATION &/or SPECIAL CONSIDERATIONS:

The Pima County Attorney's Office, Civil Division is submitting the attached contract amendment to the Board of Supervisors for approval of a needed increase in contract funding.

Attorney Ronna L. Fickbohm of the Law Firm Fletcher, Struse, Fickbohm & Marvel, P.L.C. has been providing legal services in the form of legal advice to the Pima County Board of Supervisors and, if needed, legal representation of the Pima County Public Fiduciary and the Board in connection with the claim filed by Ginger Rodgers Rappeport.

Amendment #05 will update and revise the name of the CONTRACTOR from Slosser Struse PLC to Fletcher, Struse, Fickbohm & Marvel, P.L.C. In addition, Amendment #05 will increase the contract funding amount by an additional \$ 25,000.00 to a total not-to-exceed amount \$275,000.00 to cover the anticipated cost of legal services provided by Ronna L. Fickbohm of Fletcher, Struse, Fickbohm & Marvel, P.L.C.


