Dear Mr. Huckelberry,

The Board of Supervisors is in receipt of your email dated April 4, 2022, at 10:03 a.m., acknowledging your resignation as Pima County Administrator, as well as an email dated April 4, 2022, at 5:15 p.m., sent on your behalf by your legal representative Lawrence Hecker to Chair Sharon Bronson, resigning from your Pima County Administrator position.

On April 5, 2022, the Board of Supervisors met at a regularly scheduled meeting and unanimously accepted your resignation as the Pima County Administrator, thereby terminating your employment contract with the County. As a result, your employment with Pima County has ended effective April 5, 2022. Additionally, due to your voluntary resignation, your contract provides that you are not entitled to severance pay.

On behalf of the Board of Supervisors, Pima County staff, and the community at large, we thank you for your 48 years of dedicated service to Pima County. Your contribution to Pima County over these years has been nothing less than extraordinary.

Your medical, dental and vision insurance coverages will continue through **April 30, 2022**. If you are interested in continuing these insurance coverages under COBRA, you will receive the COBRA notification from our COBRA administrator (ASI COBRA), within a few weeks. You will have 60 days to file for COBRA. Their contact information is ASI COBRA (877) 388-8331.

Your life insurance policy through Pima County is carried with Securian Financial. Any questions regarding this policy and whether it can be continued, may be directed to (866) 293-6047.

You are a member of the Arizona State Retirement System (ASRS), should you have questions about your retirement benefit or medical insurance coverage provided through ASRS, their local phone number is (520) 239-3100, their toll free number is (800) 621-3778, or you may contact them on-line at www.azasrs.gov.

All final pay will be issued via direct deposit on April 15, 2022, to include any remaining vacation leave.
