Requested Board Meeting Date: October 3, 2017

**Title:** Curtis Road and Davis Avenue All-Way Stop

**Introduction/Background:**

The reason for this ordinance is to establish Curtis Road and Davis Avenue as an all-way-stop intersection.

**Discussion:**

A safety project was recently completed to slow traffic and reduce crashes on Curtis Road; it included the installation of speed tables, the implementation of all-way-stop control at Davis Avenue, and the installation of a mini roundabout at Shannon Road.

**Conclusion:**

A safety project to slow speeds and reduce crashes on Curtis Road has been constructed. This project included the implementation of all-way-stop control at Davis Avenue. This ordinance will officially designate the intersection of Curtis Road and Davis Avenue as an all-way-stop intersection.

**Recommendation:**

The Pima County Traffic Engineering Division recommends that the intersection of Curtis Road and Davis Avenue be designated as an all-way-stop intersection.

**ORDINANCE NO. 2017-\_\_**

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING TRAFFIC AT THE INTERSECTION OF CURTIS ROAD AND DAVIS AVENUE IN PIMA COUNTY, ARIZONA**

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855, as amended, to designate stop intersections and to erect stop signs, and

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to designate the intersection of Curtis Road and Davis Avenue as an all-way-stop intersection.

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** The intersection of Curtis Road and Davis Avenue be designated an all-way-stop intersection.

**SECTION 2.** That all ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

**SECTION 3.** This ordinance shall take effect when and to the extent that stop signs are posted on the intersecting roadways.

**SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

**SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


