ITEM SUMMARY, JUSTIFICATION &/or SPECIAL CONSIDERATIONS:

Authorization to adjust Pima County's daily and hourly public parking fees, which have not been changed since 1994, to bring the County's public parking fees in line with current market rates for similar services. The requested effective date is July 1, 2014.

Statutory requirements of A.R.S Section 11-251.08 and A.R.S Section 11-251.13 for public notice have been met.

Administrative Procedure number 51-2 will be appropriately revised after this ordinance is passed and adopted.

PIMA COUNTY COST: \$0.00 and/or REVENUE TO PIMA COUNTY: Actual revenue depends on the number of cars using the parking facilities and the length of time parked. If 50% of the cars continue to park for five (5) or more hours daily, the annual revenue would increase from \$729,266 to approximately \$875,100.

Beginning July 1, 2014, gross cash revenue to Pima County Parking Operations would increase an average of 40% per car parked more than five (5) hours in County owned parking facilities, and County parking rates will more closely match current parking rates for similar parking facilities in the downtown Tucson area.

ORDINANCE No. 2014-_____

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, ESTABLISHING DAILY AND HOURLY FEES FOR ALL PUBLIC PARKING WITHIN COUNTY LOTS AND PARKING GARAGES (*All Districts*)

WHEREAS, the Pima County Board of Supervisors is authorized by Arizona Revised Statutes (A.R.S.) Section 11-251.08 to adopt fee schedules and charge fees for any specific products and services provides by the County, and

WHEREAS, the County owns and operates several parking lots and parking garages that are available for daily and hourly public parking, and

WHEREAS, the Board wishes to establish uniform parking fees for all County parking facilities that are consistent with current market rates in the greater Tucson area, and

WHEREAS, the County posted notice of its intent to establish parking fees on the County website at least 60 days prior to the date of this Ordinance in accordance with A.R.S. Section 11-251.13, and

WHEREAS, the County published notice of its intent to establish parking fees in a newspaper of general circulation at least 15 days prior to the date of the Ordinance in accordance with A.R.S. Section 11-251.08,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, THAT THE FOLLOWING FEES WILL BE APPLIED TO ALL COUNTY PARKING FACILITIES:

SECTION 1. The following fee schedule for daily and hourly parking rates will be implemented as of July 1, 2014 at all County public parking facilities:

Public Parking Hourly and Daily Rates

0 – 2 hours	\$2.00
2 - 3 hours	\$3.00
3 – 4 hours	\$4.00
4 – 5 hours	\$5.00
5 – 6 hours	\$6.00
6 – 7 hours	\$7.00
7+ hours	\$8.00
7+ hours with In/Out Pass	\$9.00*

* In/Out Pass allows a visitor one additional entry/exit on day of issue only.

SECTION 2. This Ordinance shall become effective immediately.

SECTION 3. All appropriate Pima County officers and employees are hereby authorized and directed to perform all acts necessary and desirable to give effect to this Ordinance.
