The Pima County Finance and Risk Management department is submitting this contract amendment for approval by the Board of Supervisors for the continuation of legal services from Attorney, Pamela Treadwell-Rubin, of the law firm of Goering, Roberts, Rubin, Brogna, Enos & Treadwell-Rubin, P.C.

Ms. Treadwell-Rubin has been providing legal services to Pima County since 2004 in regard to the defense of workers compensation claims filed against the County.

All other provisions of the Contract, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.




