Dear Pima County Board of Supervisors,

I am writing to provide a summary of our findings regarding the recent bid for toner supplies.

Our records indicate that Office Pal was awarded Group 1. We have protested this award on the grounds that Office Pal is not an authorized HP Reseller. In response, Office Pal's Sales Manager Latzie Tober, requested that the award be transferred to Central Jersey Office Equipment. He did not provide Office Pal's proof of authorization.

However, the bid documents submitted by Latzie Tober contradict these statements, as he bid as if Central Jersey were a DBA of Office Pal. Furthermore, we have evidence confirming that Office Pal and Central Jersey are two distinct entities and that Latzie Tober works exclusively for Office Pal.

It appears that these parties are colluding unfairly to secure this bid. We request that you review this information accordingly.

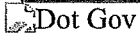
