



# Board of Supervisors Memorandum

August 15, 2016

## Tax Levy and Rate Adoption

### Background

State statutes require the Board of Supervisors to levy property taxes on or before the third Monday in August each year. Attachment A is the proposed Pima County resolution for the levy of the tax for Fiscal Year (FY) 2016/17, which includes the levies for FY 2016/17 of various taxing jurisdictions within Pima County. Of the 94 separate levies proposed for adoption in Attachment A, only four are controlled by the Board of Supervisors: County Primary, County Debt Service, County Free Library District, and the Regional Flood Control District. The remaining 90 levies are set entirely by other elected governing bodies or result from the requirements of State law. The Board of Supervisors' statutory role in adopting these property tax levies for other jurisdictions is ministerial only, and the Board has no authority to change the amounts of the various levies that have been transmitted to the County. The levies include the relevant valuations and the resultant tax rates. Most valuations are provided by the January 20, 2016 Clerk of the Board of Supervisors Abstract of Values by Legislative Class. Primary and secondary tax levies and rates for Pima County, Pima Community College, City of Tucson, City of South Tucson, and school districts are based on valuations in compliance with Arizona Revised Statutes (ARS) §42-17151. Secondary tax levies and rates for fire districts and the Fire District Assistance Tax are based on valuations pursuant to ARS §42-17052.

The Pima County Primary and Secondary tax rates (per \$100 of assessed valuation) for the last two fiscal years are shown in the table below, as well as the corresponding tax levy for this fiscal year. For a comparison of Pima County Primary and Secondary rates from FY 2007/08 through proposed FY 2016/17, please refer to Attachment B. Attachment C provides a summary of primary and secondary rates by school district. Attachment D is a comparison of FY 2015/16 tax rates to the proposed FY 2016/17 tax rates by school district and for the special districts.



The FY 2016/17 Pima County levies reflect Board actions at the June 21, 2016 and July 5, 2016 meetings adopting the County's budget and directing the levels of tax rates. The impact of the Board's actions on those dates and a slight increase in the Fire District Assistance Tax result in a total County tax rate of \$5.8852, which is \$0.0780 lower than the FY 2015/16 total of \$5.9632.

Recommendation

It is recommended the Board of Supervisors approve the levies for all taxing jurisdictions within Pima County as described in Resolution 2016-50.

**RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS  
FOR THE LEVY OF TAXES FOR FISCAL YEAR 2016/2017**

The Board of Supervisors of Pima County, Arizona finds:

1. In accordance with the provisions of A.R.S. §§ 42-17101 to 42-17110, 48-252, and 48-3620, the Board of Supervisors, acting as the governing board of the Pima County Flood Control District, on May 24, 2016, made an estimate of the different amounts required to meet the public expenditures of the district for the 2016/2017 fiscal year and, on June 21, 2016, following a public hearing, adopted the budget of the district and determined the amount of its property tax levy.
2. In accordance with the provisions of A.R.S. §§ 42-17101 to 42-17110, 48-252, and 48-3903, the Board of Supervisors, acting as the governing board of the Pima County Free Library District, on May 24, 2016, made an estimate of the different amounts required to meet the public expenditures of the district for the 2016/2017 fiscal year and, on June 21, 2016, following a public hearing, adopted the budget of the district and determined the amount of its property tax levy.
3. In accordance with the provisions of A.R.S. §§ 35-451 and 42-17101 to 42-17110, the Board of Supervisors, on June 7, 2016, made an estimate of the different amounts required to meet the public expenditures of Pima County for the 2016/2017 fiscal year and, on July 5, 2016, following a public hearing, adopted the budget for the County and determined the amount of its property tax levy.
4. The Board of Supervisors has received information enabling the Board to determine the amount of taxes and/or special assessments to be imposed on property within the various school districts, municipalities, and special taxing districts in the County for Fiscal Year 2016/2017, by or on behalf of those entities.
5. Public notice of the levy of taxes was given as required by law.

NOW, THEREFORE, BE IT RESOLVED, that taxes and special assessments are to be levied upon property located in Pima County for the entities and in the amounts as follows:
